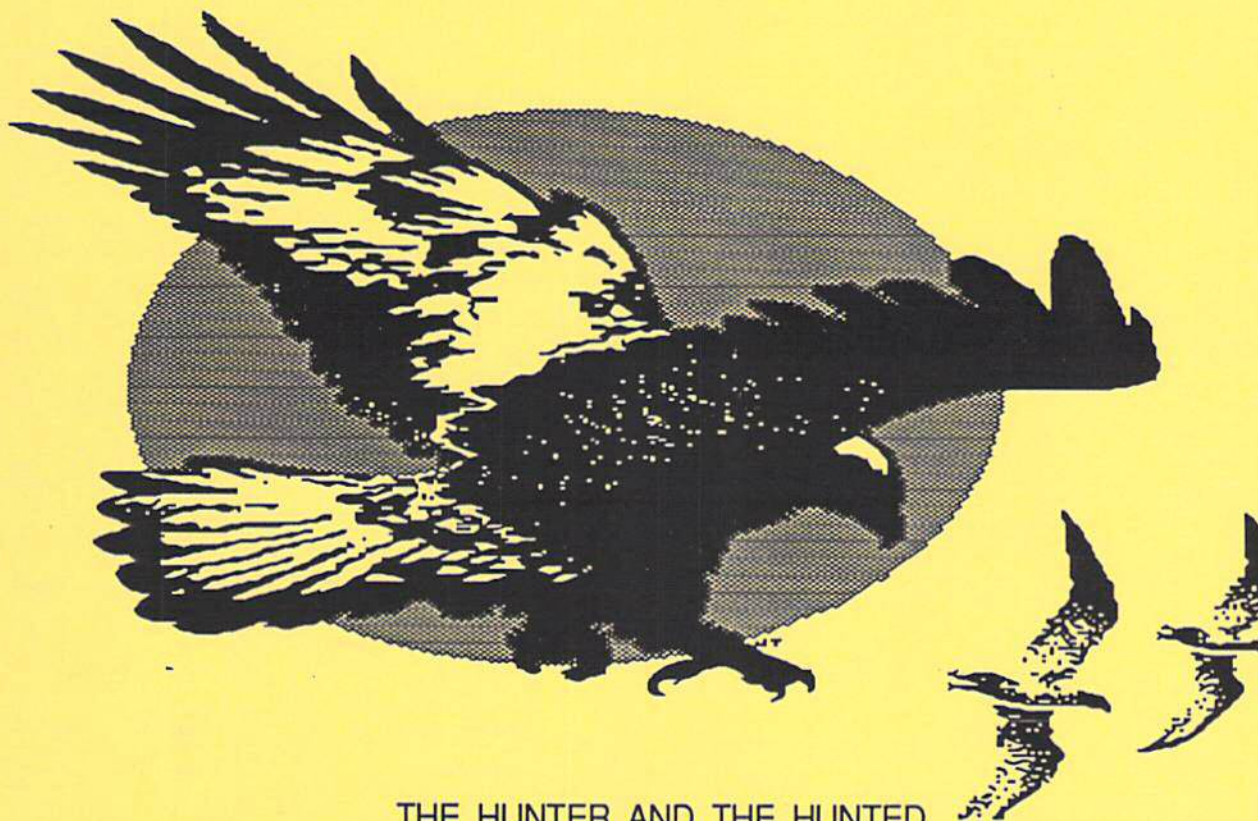

MORA conducted its own investigation of the reported Aztec, New Mexico crash and concluded from what was discovered that the crash most likely didn't occur. (See: "Aztec, New Mexico - a crash story reexamined", International UFO Reporter, September/October 1991, Volume 16, Number 5). However, as with so much in ufology, very little that we do is certain. The final word may not have yet been written about Aztec.

Ohio Ufologist Passes Away

Earl Neff, 90, of Parma, Ohio, a prominent Ohio ufologist passed away in March, 1993. Nationally known for his early work, Mr. Neff was a member of the National Committee on Aerial Phenomena (NICAP) and the Aerial Phenomena Research Organization (APRO). In 1958 he founded the Cleveland UFOlogy Project (CUP), an organization that remains the longest continuously operating UFO study group in the United States. He also hosted for many years the UFOlogy Roundtable, a radio show on UFOs and developed several slide shows for the many public lectures he gave, including lectures at Kent State University and the Cuyahoga Community College.

"He was one of the early pioneers that brought the UFO phenomenon to the public," said Mary Ann Hawk, the current director of CUP.

MORA Comment: To those of you who are new to the study of the UFO mystery and who will hopefully live long enough to see it explained, remember the pioneers who helped get you where you are today. Without them we wouldn't know as much as we do. Investigators like Earl Neff who had the courage to go against the early tide of ridicule and dogmatism are the true skeptics and the heroes of ufology.

Psi Tech, Inc. The Martians Are Coming?

The following information is taken from a report by MORA co-founder and MUFON member Rebecca D. Minshall. Ms. Minshall heard this story from Psi Tech president Ed Dames at the Treat V Conference in Santa Fe, New Mexico, March 17-21, 1993. This story was not part of Mr. Dames' official presentation but was told to 9 or 10 ufologists who met with him privately. To be absolutely fair

to Mr. Dames, this story was told by him reluctantly because of its extreme and unusual nature. He cannot prove that it's true and he realizes most people won't believe that it is real anyway. In fact, he doesn't expect them to. Like all of us, he will be waiting to see if it is true.

The information was obtained by Psi Tech, Inc. using remote viewing techniques that were developed for use in military intelligence work and are now being employed by Psi Tech in more down-to-earth commercial, profit making projects.

Mr. Dames told the small group that we (the USA) have some type of orbiting platform in space. Someone associated with this project asked Psi Tech for help in identifying a light that was seen near the platform. The light was identified as an alien space craft which later landed in New Mexico. Psi Tech also learned the following.

There was a dying civilization many millions of years ago that was nearly extinct and very sickly. They had reached a point where there was little food left and much violence was occurring among the few remaining people. As the situation became impossibly desperate an event occurred that changed the civilization's history. The skies filled with squadrons of UFOs. The 'rescuers' were far in advance of the dying species. They took the remaining people, mostly women and children, and put them in some type of hibernation off planet. The rescuing aliens which were identified as "the Federation" have been waiting for us to progress enough to nurture them [the sick aliens] back to health.

Another MORA source has identified the sick aliens as Martians. It seems that the Martian atmosphere had been somehow damaged and their civilization driven underground. From that time on the sickness, whatever it was, got progressively worse. Thus, the need for rescue became paramount if this species

was to survive. Indeed, it could be that the Martians are finally coming.

There has been a conditioning process going on of we Earthlings for a number of years with the goal of preparing us for what is about to happen. Mr. Dames mentioned the movie *Alien Nation* as a movie to watch that is in some ways similar to what will be taking place in New Mexico in the near future.

Mr. Dames feels that the whole world will know of this event by August although the exact time is hard to determine with Psi Tech's remote viewing techniques. Ms. Minshall believes Mr. Dames is saying that the sick aliens will be brought to a "colony" located in New Mexico in August, or perhaps earlier. If the landings occur earlier the world won't know about it until August, or soon thereafter. This situation will take up a lot of President Clinton's time and energy, but he will have to return his attention to more worldly matters such as the economy. Mr. Dames said that the Federation has been waiting until our medical technology advanced to the point where we could help the aliens. He said that they are humanoid looking but could not pass for humans. It will be mostly women and children who are brought to New Mexico. He said the children are mostly hybrids. If we handle this right we may be invited by the Federation to join the organization as a junior member.

Truth, fiction or a runaway imagination? Mr. Dames does have credibility, from what we have been able to learn from a known independent source. Mr. Dames speaks about this information with great care as if he himself is not sure of its accuracy or meaning. In confirmation of this story, as readers of our publications know, MORA has had a family contact story that began in the mid-1960s under investigation for over a year. The alien political organization that this family describes calls itself "the Federation."

MORA also has another piece of confirming information. A member has

been told by a retired military friend who worked closely with the intelligence community that the US. does have a manned space station in orbit and has had for a number of years, at least since 1984 and possibly before. The space station is involved with the so-called Star Wars program and is monitored out of Okinawa. The base at Diego Garcia in the Indian Ocean is also involved. The station is larger than the Sky lab was and the officers assigned to it serve five year tours, not necessarily all of this time in orbit. How the space station is supplied and the crews rotated without detection is unknown to our source. These matters were learned prior to any of us hearing about the main story line here. We will be checking up on this aspect of the story further, if possible.

Admittedly, these two items of confirmation are not proof, so we will just have to dig further and see what can be turned up. More to the point, we will just have to wait and see what August brings. If nothing else, people who are involved with the flying saucer mystery certainly come up with interesting stories. Someday I hope one of them comes up with the truth. Who knows, maybe this is it? If nothing else, the story is appealing. If it isn't true, many of us will wish that it was the next time we pick up the newspaper and read about what is happening in so many places around our world. If Bosnians and Serbs, if blacks and whites, if Irish Protestant and Catholics can't get along with one another, how can we possibly get along with a co-existing separate species? Perhaps we will soon have many lessons to learn - very quickly.

If anyone reading this article can provide further information regarding all of this, please let us know as soon as possible.

Confirmation Of Ufology's Darker Side?

The following material was originally published in the Ohio UFO Notebook.

Supplement 1-92, July, 1992, pp. 11-14. A sighting from Saudi Arabia during the Gulf War detailed in this Supplement, which is not repeated here, was noted in the March 1993 combined Ohio UFO Notebook and MUFON of Ohio Newsletter. Most of the Ohio MUFON members have not read this material, other than the Saudi Arabian report, and since the Supplement is no longer available, it is repeated here for their information.

There are times when you meet an informant with a story and you just know he is trying to tell you the truth as best he can. If the subject matter cannot be proved either because of its transient nature or because it relates to matters of "national security," the only tools with which you have to judge the informant's story is your assessment of his character and the demeanor by which he tells his story. These tools were used by MORA's Rebecca D. Minshall and William E. Jones. In this instance our informant's character seemed high and his demeanor was believable. Our problem is that we can't check out the person or the story any further. Why? If what we were told is true our informant's life and new civilian job could be placed in jeopardy if we attempt to pursue the story through independent sources. If what we were told is true the proof is buried deeper than we can ever hope to go independently. You can take this story for what you think it's worth. The two of us think it might be worth a lot.

It started out as a lead to an abduction story. Through the lead we met our informant and a relative. We thought the informant, who we shall name Frank, was merely accompanying his relative to our first interview to give support and to help assess our trustworthiness. We learned early in the interview that there is an abduction story here involving this relative. (At this time we don't know much about that story yet - we hope to learn more in the future.) However, it was our informant's story that caught our interest during this interview.

As we talked to these two people for more than five hours, the story came out hesitantly. In the time allotted we only learned bits and pieces of what our informant apparently knows. Some of what he knows is obviously so sensitive that he will never reveal it. He said as much. Other parts seem only partially remembered, as if he may have been programmed to forget. The rest of the story - that part that he seems to want to discuss with knowledgeable people that he can trust - came out as noted below. We won't attempt to make a narrative here because it would not be meaningful. These are the bits and pieces that he told us.

Frank was in the US. military; he is now retired. At various times during his career he had access, both granted and accidental, to a lot of information about the government's knowledge of UFOs. So that we won't provide anything that can identify him, that is all we shall say. If that makes the following information less believable, so be it.

Early in our interview he said, "I suppose you know about the missing children." We replied that we had heard rumors of this but knew nothing for certain. He said that children were being taken away to secret bases, mentioning one that is on or near Nellis AFB in Nevada. Some of these bases are underground and are used for genetic studies and other related purposes. Most of the children he believes will never be returned to society, destined to live out their lives in these secure facilities. However, he did say some have been returned to society years after they were taken, most ending up on the street. He does not know why this has occurred. (Note: We don't know if he is claiming that the aliens, the Government or a combination of both is doing the kidnapping.)

We asked Frank about what happens to government connected people who can't handle the knowledge they have been

provided about the alien presence on this planet. He replied that many are removed from society and are taken to special facilities where they live outside of our society. Sometimes their families go with them.

Arizona and New Mexico are the current locations for much of what the government is doing with regard to the alien presence.

He confirmed that there are agreements between earth governments and the aliens. There was a re negotiation of some of these agreements in the mid-1970s. The earlier agreements had been broken in some ways. When asked why the 1973 flap occurred and if it had something do with these re negotiations, he replied that the aliens put on this show of force as a negotiation technique.

Frank knows that the Roswell crash occurred because of what he has read and been told as a part of his military career. He did not have to read the book, *UFO Crash at Roswell.*

There is more in Cheyenne Mountain near Colorado Springs, Colorado than NORAD. The other part of the facility has something to do with the aliens.

There are liquidation lists kept for the purpose of silencing those official people who have worked in some way on the alien issue and who start talking seriously. He is afraid that he is on this list.

He asked us if we had heard about the "Black Report." When we replied no, he said it was a daily report issued within the government that reports on the status of the alien issue from a "world wide" perspective. (We have since heard from an independent source that a report of this or a similar title is published within the US. intelligence community. The content of this report is not known to this source.)

Frank believes that there are three crash/retrieval teams on the east coast of

the US., two in the middle of the county and three on the west coast. There is a "recon" facility near Ft. Carson, Colorado.

He has heard that there is a government in the US. that is "higher than the president." He asked if we remembered President Bush's use of the term "new world order." He said that it exists on a world wide basis. When we asked if the aliens had a role, he acted surprised. He then replied, "They are the government." When we asked if he had ever heard of the Bilderbergers, he acted very surprised. He said, "Where did you hear that term?" When we answered it was referred to in the open literature, he just shook his head in amazement. It was if he hadn't known that. Several times when we indicated our awareness of things like this he said, "You've really done your homework."

Frank did confirm the Majic/Majestic security clearance classification.

When we asked if some of the aliens looked like human beings he got upset and said he had to go for a walk. He went about twenty feet away and stayed for a couple of minutes. He then came back and said that some did appear that way. He said their heads are shaped differently. From the front the face appears large at the top and then tapers to a jaw more pointed than usually found in humans. He also said their eyes are different. The pupils look more dark behind the irises. Some of the aliens are genetically engineered to look like humans before they are born. Others are changed to look that way later, much like a plastic surgeon might work on a real human.

Frank asked us if the word "thinkers" meant anything to us. We replied in the negative. He stated that the government has learned how to combine the minds of two people. One person will know what the other person is thinking and experiencing, even though they have never met. This is used by the

government as a security technique to help determine if someone trained in this method is talking about something that is highly classified. When we asked if he was concerned because he was talking to us, he replied that he wasn't because he had learned to beat the technique.

He stated that there was an actual landing on a platform or flat area similar to the one depicted in the movie *Close Encounters of the Third Kind*. Further, with regard to underwater UFO stories, the movie *Abyss* was very close to the truth. He claims there are underwater bases that are used by the aliens.

He discussed the government's use of "ghost battalions." The Army's Special Forces, the Navy's Seals and a number of other special operations organizations have their public units. They also have other units hidden within the regular service ranks. When a mission is undertaken the people in these units are removed from their regular duty stations and organized in secret. A reason for the individual's absence is provided for the record so their absence won't seem unusual, for example a family emergency. If someone in the regular unit gets too inquisitive, they are taken away and debriefed, i.e. told to mind their own business. These inquisitive people might even be transferred. The people in the special units are not supposed to know where their comrades are officially assigned. They only meet and work together during these special operations. Since each person is unaware of the other persons' assignment, this keeps loose talk to a minimum because one never knows if one of the other people might be from the CIA or some other security organization. The special missions may keep people away from their official units for up to sixty days, sometimes longer.

Comment: Could this have been an attempt to place misinformation into the UFO mainstream? Possibly. Objectivity and true skepticism should be applied here. We want to wait until other

information comes in before reaching any conclusions about Frank's report.

Bits and Pieces

New MUFON Officers Appointed

Bill Jones of Upper Arlington, the editor of this Notebook and co-founder of MidOhio Research Associates, has been appointed MUFON State Director for Ohio. He replaces Fred Hays who has resigned to pursue his many other public service interests.

Rick Dell'Aquila of Parma has accepted the position of MUFON Assistant State Director for Northern Ohio. Rick will be responsible for the two northern Ohio districts, one centering on the Cleveland/Akron/Canton/Youngstown area and the other centering on Toledo. Hopefully Rick will be able to find someone for the Toledo area who will be willing to accept that responsibility. Currently planned are four other districts centering on Columbus, Dayton, Cincinnati and Southeastern, Ohio.

Patrick J. Packard of Fairfield, Ohio has been appointed as the Assistant State Director for the southern district centered on Cincinnati. Delbert E. Anderson of Laurelville, Ohio has been appointed as the Assistant State Director for the southern district centered on Circleville and Portsmouth. As a state Section Director, Dr. Irena Scott has been reassigned the counties of Marion, Morrow, Delaware and Knox. Franklin B. Reams has been appointed as the state Section Director for Licking, Fairfield, Perry and Muskingum counties. These appointments are awaiting ratification by the MUFON national organization. In the meantime these individuals have the full authority of that go with those positions.

The MUFON state leadership needs to be within cheap or free calling distance of the local membership so that we can all remain in some sort of regular contact and can cooperate in local investigations.

Important in this organization are the MUFON State Section Directors who are appointed to be responsible for one or two counties. Ohio has a number of good section directors. These people need to work closely with their respective assistant state directors. We will hopefully find more section directors to cover the unassigned counties as time passes.

As the MUFON organization grows, we all need to remember that many good ufologists work outside of the MUFON umbrella. Their assistance and cooperation is needed if Ohio is going to be a strong state. Work with them and pass information back and forth as the opportunity presents itself. Keeping in mind requirements of confidentiality, information that is not shared is worthless.

Corrections

Two errors have been noted in our combined *Ohio UFO Notebook/MUFON of Ohio Newsletter* dated March 1993, proving that I need practice as an editor. On page 4 the word "foundation" appears in a title. That word should be "federation." For some reason I want to use the word "foundation" even though our story teller has specifically stated the aliens she is in contact with call their political organization (the last two words are mine, not hers) "the Federation." Also, on page 17, column 1, paragraph 3 the date "November 6, 1945" appears. The year in that date should read 1954. I will try to do better in this issue; Dr. Irena Scott, editor of MUFON's non-Journal publications and a MUFON Board member, has been appointed our editor as well.

George Bush Makes A Statement About UFOs

The Mutual UFO Network's Journal reported recently that during the last presidential election a MUFON State Section Director, who was serving on the

President's campaign committee, asked President Bush about his knowledge of UFOs and the CIA. The President responded in a tape recorded statement that, "You don't know the half of it."

Given the possible significance of the President's statement, we have written MUFON's director, Mr. Walt Andrus, to ask him if anyone plans to follow up. It seems to us that some enterprising reporter or journalist should ask the ex-president about the statement at his next public interview. Who knows what more he would be willing to say? Who is the unnamed State Section Director? It's time to earn your title. Do something important. Do a little follow up.

Cattle Mutilations, Mysterious Lights Seen in Colorado

San Luis, Colo. (AP) -- The return of cattle mutilations reports in the San Luis Valley has brought with it a surge in reports of mysterious lights in the night sky.

The inexplicable incidents began recurring last November..."I got up about 3 o'clock in the morning, and I saw a bunch of lights overhead," said John Browning, 54, of Denver, recalling what he saw during a hunting trip near Saguache last November.

"There must have been 15 or 16 of them," he said. "They were in a kind of semi-circle, and there were four lights moving around in the center of the circle, and there wasn't a sound in the sky."

In early December, Andrea and Mike Nisbet of Crestone awakened in the predawn hours to find a bright yellow-orange shining through their bedroom windows.

"The light was coming from directly above our house. I saw this big, round yellow-orange light in the reflection off our van outside," Andrea Nisbet said. "We were amazed at how bright it was outside. And there was no sound."

Retired Costilla County Sheriff Ernest Sandoval, who held office for 16 years, recalled there were reports of unusual lights when the mutilations were being reported in the mid-1970s. He said he saw some bright lights near San Pablo one night, then later learned there were two mutilation reports that night.

The Federation Story Continued

This article documents the most recent events in the ongoing story of Jane (a pseudonym) and her family that was first introduced to the UFO research community in the February 1992 issue of the Ohio UFO Notebook in an article entitled "The Federation and Its Star Children - A Family History of Contact." The material was collected during two interviews in February and March of 1993.

Note: I. This letter designates the questions or comments form one of two investigators. J. This letter is for Jane's comments.

First Interview

J. (Jane comments on an event that her mother remembers back when the family was having experiences in the mid-to-late 1960s and early 1970s.) She (Jane's Mom) recalls specifically Dad, Linda, and Carol and my grandfather and grandmother...She said they started to go to the TNT area [the TNT plant in West Virginia made famous in John Keel's story of the earlier Moth Man saga] and

my aunt Carol got a terrible, terrible nose bleed...Grandpa said that they didn't want us to go there. They would do things like that...basically harmless things...to send you back. (Her mother thinks this occurred in the fall of 1974 after Jane had left home.)

...

I think the aliens are able to change form. I don't think...they can become a snake...or a trash can. I believe they are able to change molecular structure...they are able to reduce or emit energy when they do that.

I. Where do you get that [information]?

J. It's there. [It just comes to me when I am reading things or thinking about things.]

...

They don't really park these saucers anywhere. There is not a big city of UFO people. They kinda live out of these saucers....I don't believe they have big colonies. They're researchers. They are 'knowledgers.'

...

[The aliens are currently interested in our food production methods.] They want to know about the whole life cycle of things and how much energy we expend...They don't use that much energy. [Their needs are minimal.] They can get the specific minerals and vitamins they need [without consuming large amounts of food]. I don't know that theirs our comparable to ours [vitamins and minerals].

...

[I get a sense that their food is in a powder form that is made into blocks. A lot of their needs are just taken in from their environment. This is true for the aliens communicating with me. I don't know about other species of aliens.]

...

I. Get any sense of where this is going to go, for you?

J. No. I continue to believe I am going to be a role model for future relationships between humans and aliens. Still a lot of

government priming going on, I think. They are priming the government.

There's a great amount of emphasis in our race, our species, put on leadership. We are a species that does need to be lead, you know, we can't just be. And that is one of our problems, by the way. It's one of the qualms they have with us...That is troubling to them. They just exist. They don't need to work. Their research is their work. Learning to live in harmony, in unity, is their work. They don't have jobs. They don't have money. They don't have any of that.

They're not necessarily saying that that's what we need to evolve to. We need to get to a point where we are a more equal society...we look at each other with more respect.

...

I. You said at one time that they didn't understand entertainment.

J. Yes...they still don't get that.

I think there's this misconception that the UFO people are so advanced that they get everything. That's not true. There's a lot of thing they can study. They can explain it. They have observed it. They know about it. They are knowledgeable about it. They know what it's for. But they don't get it. They're never going to get it.

...

There's not this suggestion that we should be everything that they are. We are a different species. They acknowledge that. Their big point is that we are a very dysfunctional species.

...

I think the bad faction walked a real fine line with us (our family) in the early days of our experiences. I think they tried [to be an influence].

I. Where you protected?

J. I think I was. Talk to my Uncle Ron and he's not going to tell you that. Not only does he tell you about it, but you can see the look on his face. This guy's

really scared. He really does not want anything to do with this...even today. I think he was abducted...and the experience was not a good one. I think it may have been the only experience of the bad faction with us.

It's my opinion they toyed with us and he was the one they [really] toyed with.

I. Once or more than once?

J. I don't know. At least once, for sure.

Second Interview

Jane had just finished reading The Tujunga Canyon Contacts by Ann Druffel and D. Scott Rogo, and she called us to talk about her response to it.

J. Reading this book...has jogged my memory. It's made me realize...in playing the recall game...and there is a distinct possibility that more has happened to me than what I was initially aware of, Bill.

I. Why do you say that?

J. There are several things that this book has made me remember that I didn't remember. Quite frankly I don't think I deliberately blocked it out, but simply believed that it didn't have any significance.

...
I had this dream one night. I am using that word dream...I need other people to be a guide here. My brother was in this dream. We were in this auditorium, for want of a better word. I am not sure that would be what they would call it...Very large. The atmosphere was different. It wasn't like the air we breath. It wasn't difficult for me to breath, but it was different.

I didn't fall asleep and have this dream.

...

This auditorium - it feels so wrong to use that word, but I can't explain why - is speckled with people. People I didn't know, other than my brother. My brother was very excited to be there. I don't recall feeling afraid...he wasn't afraid. We were waiting on something; I'm not sure what...We were all there for a common purpose. I don't know what that purpose was. I never got that far.

The lighting in the place was weird, not like any specific color. Just kinda hazy. It was well lit. At the same time it has a weird texture to it.

I know I've been in this place before...I definitely got the feeling it was in a mobile environment.

The seating was weird, too.

I. How did they feel?

J. I don't know.

I. Did they fit your body?

J. Yeah! Yeah! They weren't uncomfortable but I don't remember sitting in them and saying, "These are so comfortable." I just get a sense that they were different from any chair I've ever sat in.

...

I. You don't know what happened? What the purpose was?

J. No. I wish I did.

...

I got the sense more people were coming.

I. What were the seats facing toward?

J. It wasn't really a stage...It was kinda like a void, but you knew something was going to take place there...It was a void. Nothing there. Black.

...

There was a railing. it was almost...the closest thing I can describe like it is [the banisters on a cruise ship I was on]. It was like Plexiglas, of sorts, but a thick railing.

...
There were corners in it.

...
There weren't people up by the railing.
It was a walkway. No seats up there.

...
There was this void place, then the railing, then the seats. That's why I call it an auditorium.

...
Everybody there was in good spirits. I got a feeling that the people who were there, none of those people were forced to be there...They were chosen to be there.

...
I got the distinct impression that we were there to gain information. To gain knowledge. Everybody there had a working knowledge that there were UFOs. There are aliens. We've got a relationship with them. We had been chosen to do that, we were happy to do that and we wanted to do it. That's the impression I got.

I. Was this a memory of a past event?

J. I don't think it was a memory of a past event.

I think past events have taken place in this place, but I think this was a very present event.

I. Did it take place when you dreamed?

J. I got that impression.

I. When did this dream happen?

J. [March 26, 1993.] A Friday night...actually Saturday morning. It happened after 1 AM.

What do you guys think?

I. [Joe thinks it was a dream or astral experience. Jane isn't so sure. It was a very physical event to her.]

J. I have a physical sense of having been there. Been at this place that I know is no where on this Earth. You would be very hard pressed to convince [me otherwise].

I. Do you have any sense of where this was?

J. Far, far away. Out there somewhere.

I can't shake the impression that this is some kind of contact. I really have that feeling....I am not in the position to judge, but...

...
When I was young, like 8 or 9, I can remember being above my house. Above my house. I mean pretty high above my house. But I was hanging onto something. I'm not sure if it was the antenna or chimney...I'm not exactly sure.

I can remember looking down on my house and being told that I could let go. That it would be all right to let go and that I would not fall. Nothing was ever...spoken. [I just knew.] It took some convincing. I did let go and what happened is I didn't really fall...I came down to the clothes line. It wasn't like a bird...I remember having a sense of floating...moving very, very slowly. No wind. It was very still. It is my inclination that I was not in my body when I had this experience. It was an out of body experience. It was very real. I could see things with great clarity...I never talked about this before. It is coming back.

...
I think this was a mental exercise...in preparation for things that are going on with me now...and in the future. I get a sense that it is totally alien related. They wanted me to be able to focus.

I wasn't asleep during this exercise. No way. I was very much awake.

Jane asked to be placed under light hypnosis as a way to enhance her memory about some issues that were of concern to her. Some of what was learned is included below.

I. Describe to us what is occurring.

J. *(Jane goes back to an event that happened to her while she was returning from college by automobile to her home in southern Ohio. These events have been covered in earlier MORA reports on this case.)*

There's stuff on the windshield. A film of some kind. I can't wipe it [off]. It's distracting somehow. It's annoying me. It's warm, the windshield is kinda warm.

The tape stopped. Something made the tape stop. The car won't start. The car won't go. It's still running but it won't go. The lights are on. I think maybe it's a transmission problem. I keep working the gear shift, but it won't go.

I'm tired. I feel very fatigued. I can't drive any further. I don't know what to do; I don't know what's wrong with the car.

I stay inside the car. The light, very bright light, very small. Sort of like a pen light, but very bright. Brighter than anything I've seen. It's not hot.

...

I can see them.

I. What do they look like?

J. Silhouettes. I cannot see their features, and I don't understand that...They want me to help them.

I. In what way?

J. I can't hear them...They're not talking. They talking but they're not talking.

I. You're hearing it mentally?

J. Yes, but it's hazy. They say, I'm important to them, somehow.

...

There's about five at them. They are at some kind of table, but I can't see the table.

...

They say they want me to help understand, but they won't say what.

Understand my family is one thing. It's not clear.

...

They say there is a limited number of open minded people, but that is not how they said it. I don't know how to say it.

I. Why have they chosen this time to contact you?

J. The time had to do with them, not me. They said they had to be in agreement...They won't tell me what that means.

...

They won't force me. It's my choice.

I. What is that choice?

J. I am afraid. I don't trust them. They say if I trust them they will come back. They don't have any more time. They have to go now.

I. Are you in your body or out of body?

J. We're above the car. I can see the car.

I. Are you in the craft?

J. No, we're in the light. I'm inside the light.

I. This is a blue light?

J. No, it's a hazy, a misty light.

I. Oh, it's a bright green. *(Joe is trying to see if he can lead her story.)*

J. No, but it's hazy. It's grainy. Like when you shine a flashlight [through dusty air].

I. Go on.

J. They're gone. I'm back in the car.

Recent Sighting in Delaware County

It was March 4, 1993 at approximately 12:45 AM. Ms. Kim D., age 35, had left South Bend, Indiana at 9:00 PM for a trip to Columbus, Ohio. She was driving south bound just across the Marion/Delaware county line on US Route 23 which is a divided four lane highway. She saw lights ahead on the road she thought might be a police car turned sideways on the median. As she got closer she noticed that the lights were on the far edge of the north bound lane and came from an object hovering about fifty feet in the air. She pulled up abeam of the object and stopped her car in the left of the two south bound lanes. It was about sixty feet from her. Excitedly she rolled down her window. The object floated down to about fifteen off the roadside. It made no noise.

The bottom of the object was a charcoal gray and had small clear lights around the circumference. There was what appeared to be a clear dome on top in the shape of a fastback car. There were two large square lights on each side where the dome met the bottom of the object. The object was a little larger than twice the size of her car.

She watched the object hover for awhile and then found the courage to get out of her car to approach it. Before she could do this, the circumference lights went out and the object took off away from her at an extremely high rate of speed. It seemed so fast she thought the object might have disappeared after it started moving.

Kim left the area and two miles further south she was stopped by an Ohio State Highway Patrolman for going 62 mph in a 55 mph zone. The officer gave her a warning and, when asked, stated that he had not seen the object.

MORA has the warning ticket and has also interviewed the patrolman to help confirm Kim's story. The ticket noted

that Kim was stopped at 12:53 AM, helping to further confirm the story.

The weather that night was eight to ten thousand feet overcast and seven miles or better visibility.

Kim was interviewed on March 5, 1993. On March 9 investigator Frank Reams took Kim to the site so that the area could be specifically identified and surveyed for possible ground traces. None were found.

Contact was made with the Marion County Sheriff's office to see if any UFO reports had been made to them recently. None had.

Human Mutilations Again

GENEVA (AP) -- An international human rights group said yesterday it has evidence of a growing trade in the organs of children and urged the United Nations to investigate.

The World Organization Against Torture cited the example of a young boy found dead with his eyes missing in Columbia. A young girl was kidnapped and her eyes were removed before she was returned, alive, to her family.

Witnesses, including the blinded girl and her family, disappeared shortly after, making further investigation impossible, the group said.

For several years, there have been reports of children in Latin America kidnapped and even killed for their organs, but there has been little proof. Latin American governments have denied the allegations.

...

The report said children targeted for illegal adoptions are particularly at risk because it is impossible to trace them.

...

[The] population of street children is exploding because of Latin America and the growing number of orphans whose parents died of AIDS in sub-Saharan Africa.

It said the Brazilian situation regarding street children [is] a "horror."

A Brazilian parliamentary commission of inquiry found 4,611 street children were killed by death squads between 1989 and 1992. The report said campaigns against street children in Guatemala were more limited in scope but just as brutal.

In Haiti, it said that such children are systematically killed by the armed forces.

Rumors of human mutilations and missing children have been found lurking in the darker corners of ufology for several years. If we are going to consider the possibility that these rumors may contain some truth, we should be knowledgeable concerning the extent of what is known about these matters from a non-UFO point of view.

Further, if you are concerned about what the aliens are reportedly doing to humans during abduction experiences and to cattle and other animals out in our pastures and back yards, this article shows that we human beings are much better at creating genuine horrors than the aliens ever hope to be.

Informant's Story

In 1986, according to an informant* who is not unknown in certain ufological circles and who recently made himself known to MORA's investigators, President Ronald Reagan asked an unidentified Federal agency to seriously investigate the reality and origin of the abduction phenomena. According to this

informant, the study was undertaken with many reported abductees being interviewed and studied. The results of the study were inconclusive, i.e. the validity of the phenomena could not be established.

Why was President Reagan interested in abductions? Reportedly, there was concern on his part and the part of some of his military and political advisors that they were being lied to because of the rising number of abduction stories that have become public knowledge. A reason for this mistrust, at least in part, is that the two alien groups have denied any knowledge of these reported abductions. They admit that there are civilizations in space which would be potentially harmful to us. However, we have been told that the members of these civilizations can't get here. Why? Our informant did not know.

It seems that the Earth is currently being visited by two alien races, the so-called Grays and the Nordic Blondes. Both of these races come from planets in the Zeta Reticuli star system. At one time in the far distant past these two races were at war with each other, but they have long since made peace and now explore the stars together. In short, they have arrived here.

Both of these races have been in contact with some Earth governments since at least the late 1930s. Over this period of time they have traded some technology for the right to be here. In recent years both the US and Soviet governments have instituted large programs to explore and attempt to take advantage of what we have been learning from these beings.

At one point in time Wright-Patterson Air Force Base was a center for these studies in the United States. The remains of the Roswell crash and other crashes found their way there. In the past several years, however, the importance of this center has been significantly reduced, as Los Alamos and Groom Lake have taken over.

When asked what the aliens are doing here, our informant stated he has concluded, based on all of the facts made known to him, that the aliens are cross breeding with humans in such a way that the alien genetic influence will be small but very meaningful. They are attempting to breed in certain traits that they want to see. Thus, all of these cross bred "humans" who are born in our midst will appear completely normal but will, in fact, carry certain alien influences and special abilities. What these influences and abilities are, our informant couldn't - or -wouldn't say, with one exception. An abductee/contactee he is currently investigating who may carry some alien traits has the ability to ignore the presence of physical obstacles like walls. It is an ability that scares this person and she only used it one time.

Given our informant's revelations that Los Alamos has become one of the key centers for alien research and that one of the alien purposes is genetic engineering of the human species, we were reminded of another informant's story that we had heard recently. This informant lived near Los Alamos in 1991 and was involved in volunteer work in the community. As a result she became acquainted with a key Los Alamos official. During a conversation that occurred during one of the group's meetings, the official said that he was concerned about something that he had gained knowledge of through his position at Los Alamos. He was reluctant to talk about it, but finally revealed that it involved "human engineering" and that it was highly secret. He would say no more, but it was clear that what he knew troubled him deeply. Is there a connection? Obviously, we don't know, but this certainly should be enough to cause all of us a bit of concern.

The aliens have admitted to our government representatives that they are involved with the cattle mutilations. When asked if human mutilations are

occurring, our informant replied, "No, we know of none of these."

Those factions that know of the alien presence on our planet are not in total agreement about what the public should know about the situation or what can be done about it. Some believe it is time that the public be told at least some of what is known. Others want to say nothing. Because of the amount of information getting out through non-government sources, some misinformation is being released. This misinformation contains some small amount of truth.

When asked about what the presidents are told about these matters, our informant replied that while Jimmy Carter was told nothing during the first six months of his presidency, George Bush as Vice President was the head of the organization that was once known as MJ-12. Each apparently is treated differently.

This is a story that is not all that different from many others that we have heard and read about over the past few years, with the exception of the Ronald Reagan abduction study claim. The same or similar claims to those noted above can be found in the following books: Cameron, Grant and T. Scott Crain, *UFOs, MJ-12 And The Government - A Report on Government Involvement in UFO Crash Retrievals*, Mutual UFO Network, Seguin, TX, 1991; Good, Timothy, *Alien Contact - Top-Secret UFO Files Revealed*, William Morrow and Company, Inc., NY, 1993; and Good, Timothy, *Alien Liaison - The Ultimate Secret*, Century, Random Century Ltd., London, 1991, the foreign predecessor to the other Good book noted here.

Has anyone out there heard claims similar to these from any other reasonably reliable source? We will continue to follow this story, if possible, to see where it leads. We are hopeful that our informant will keep in contact with us.

*The informant has requested anonymity with respect to his contacts with MORA. This request will be honored, even within the MORA organization itself.

Clovis, New Mexico Another UFO Crash Site?

Recently, MORA investigators interviewed a man we shall give the pseudonym Jake. Jake served in the United States Army/Air Force from 1951 through 1960. At the time of his experience near Clovis, New Mexico he was a Master Sergeant serving as a crew chief on fighter aircraft. He was on leave, traveling with two Air Force buddies from Kansas into New Mexico. They had no particular destination in mind; they just wanted to get away from work for awhile. The specific time period involved is uncertain, but it was in July or August of either 1957 or 1958.

They had heard rumors about a crash of some kind in New Mexico shortly before going on leave, mostly from returning pilots who had over flown the reported site. There was speculation among these returning pilots that the crash was unusual because no tail section could be seen among the wreckage.

When they left on their trip, starting from McConnell Air Force Base, Wichita, Kansas, they did not set out in an attempt to find the site, but as they got into western Texas they began to hear further rumors about the crash as they talked to people they met along the way. So they decided to see if they could find out more.

The site, as best as Jake can remember, was 30 to 35 miles southwest of Clovis. It was on a ranch. They found the site rather easily, first locating a couple of military vehicles out on the highway and then following them in. They encountered no road blocks. When they arrived at the site, on a dirt road just off a small two lane paved road out in the country, they noticed a number of military vehicles parked near the top of a small rise. Included were a number of jeeps and trucks, a Buick staff car (one of the vehicles they had followed), a C-2 wrecker and two or three O-10 fire trucks. Since the area was supposedly an aircraft crash site, Jake thought it was strange that no ambulances were there. He stated that ambulances are usually kept near aircraft crash sites, even after bodies are removed, in case they are needed for the treatment of injuries incurred during the investigation and cleanup process.

Jake and his friends were spotted soon after they arrived since they were in a civilian car and wore no uniforms. However, just before this occurred one of his friends noticed a small piece of material on the ground, which he picked up.

The material was grayish charcoal in color. It was oddly shaped and slightly bent, but it had not been broken. It was approximately 18 inches long, 10 to 12 inches wide and 5/16 of an inch thick. He remarked that it was the same color all of the way through. It was light in weight, perhaps 3 to 4 ounces. Neither of the three had ever seen any material like it. The friend scrapped the material on a

rock which created a scratch on the material's surface.

An Air Police officer came up and demanded that they put the piece back where they had found it. Jake's friend threw it to the ground. It hit a rock. The sound this made was not metallic, but more of a light thud. The police officer told the friend to pick it back up and place it back where it was originally found. This he did. The officer then demanded to know who they were. When they identified themselves they were told to leave the area immediately.

Several other Air Force personnel had come up to them at this point, one being a "full bird Colonel." This individual ordered them, "What you see here, you forget." They got back in their car and left the area. The Air Police followed them for some distance.

The three never did see what had crashed. There were small pieces of wreckage around the area and ground marks that indicated that something large had impacted in the area, possibly having gone over the small rise in the land. The sparse bushes and trees in the area had been crushed and disturbed and a telephone pole near the road was broken off.

Scuttlebutt, picked up both before they arrived on site and later, led them to conclude that the crash had occurred perhaps 3 to 5 days before, but the inspection team had arrived within less than twenty four hours before their arrival.

Neither Jake nor his friends were ever approached later about the event. They never saw the crash referred to in the newspapers. The rumors around their base about the event died out soon thereafter and that is where the story ends.

This event cannot be identified as a crashed UFO, but it is clear both from what Jake and his friends had observed

and heard that a crash of some type of aircraft had occurred and it was apparently being treated somewhat differently from a regular plane crash. Unless more is learned from other sources, this is all that can be said about the incident. We report it here only to put it on the record. If anyone has information about a crash near Clovis, New Mexico our informant would like to talk to them about it. As a matter of fact, so would we.

This was not Jake's only possible UFO related experience. In 1956 "towards fall" he was riding in a T-33 trainer over Lake Erie, having gone along for the ride with a pilot friend of his. They had flown from Michigan, down into Ohio and back to the lake heading north-northeast when Jake spotted something in his two-o'clock position. They were at between 15 and 18,000 feet altitude. Ground speed was approximately 400 mph. It was early evening, perhaps around 7:30 PM (1930 hours).

There, perhaps 400 to 800 yards distant, was a large dark gray colored object, apparently pacing their aircraft. It looked like a flying whale with two vertical fins in the rear and a saucer shaped front end. The top of the front part of the object was flat and dark window-like shapes surrounded the saucer portion near the top. A yellow-orangish glow emanated from the center bottom of the craft. Jake estimated that the object was 30 to 35 feet high and 100 to 150 feet long.

They turned toward the object, but it moved away. Several attempts at closing with the object were met with the same response. Somewhere over Canada the object took off at a fast speed, turned upward and disappeared. At some point during this encounter the pilot turned on his gun camera. The camera light came on, as Jake remembers.

As they turned to fly back to their base, the pilot noticed that the aircraft instruments were not working correctly.

They "went berserk," was the way Jake described it. The overheat and fire warning lights came on. The radio compass didn't register correctly. The altimeter was stuck. Their radio would not receive, but they later learned that it did transmit. Their air speed indicator did not work.

After they returned to their base they made a report and were interrogated by a major from Air Force intelligence. Jake thinks the man might have been named "Kern". The pilot's name is forgotten but his nic-name was "Mighty Mouse". Two days later Jake and the pilot were again interrogated, this time separately by four intelligence officers from off base, one a female first lieutenant. They were given lie detector tests and then advised that they had "flunked". They were told that the gun camera films showed nothing and that their aircraft was stripped down and checked out and nothing was found wrong with it. After this experience Jake swore he would never report another UFO sighting, should that ever happen.

Several years later, after his experience at Clovis, Jake had another sighting northeast of Albuquerque, New Mexico. He was flying in the engineer's seat on a C-54 transport. They were at 8 to 10,000 feet traveling northwest when the pilot sighted four gray oblong objects to the northeast pacing their aircraft. They had these objects in sight for approximately fifteen minutes. After the sighting was over the pilot asked if anyone wanted to report what they saw. This pilot had made a report of a sighting over Nevada some years before and had an experience with Air Force intelligence similar to Jake's. No one wanted to make a report, and they didn't. They both admitted to each other that they really hadn't seen anything.

UFO Crash Report South Haven Park, New York

Just before going to press, MORA has learned from John Ford of the Long Island UFO Network that his group has solved the reported Southaven Park UFO crash case, through cooperation with an anonymous Department of Defense source. This crash is reported to have happened on November 24, 1992. The group has been given segments of a film indicating the retrieval of some wreckage, along with the recovery of alien bodies, two of whom may have been alive at the time the film was made. The group is negotiating with the *Unsolved Mysteries* TV program on how to bring this story before the nation. Mr. Ford responded when questioned about possible government harassment that this has happened. However, Mr. Ford and his people refused to be intimidated and the government, at least for the time being, backed down.

Mr. Ford has assured us during a telephone conversation that in no uncertain terms this event is real.

Has someone finally grabbed the brass ring or are we soon to be disappointed once again after being told that unequivocal evidence has finally been found? Only time will tell. If true, John and his group will certainly go down in history.

GIANT UFO BASE HOMES IN ON EARTH (or do editors steal?)

The first article in the Ohio UFO Notebook (3/93) refers to a planetoid rapidly approaching earth. After an investigation of the source of the story, the author concluded that perhaps this was one of UFOlogy's "urban legends:" "MORA has found a reference that indicates the story goes back to at least November 1988...Perhaps the most interesting question here concerns the origin of the story. Where did it first come from originally? Is this an example of planted misinformation?"

It is possible this story inadvertently originated from a MORA executive member, me, and began long before 1988. On 12/30/83, I read the following: "A heavenly body possibly as large as the giant planet Jupiter and possibly so close to Earth that it would be part of this solar system has been found. It was spotted in the direction of the constellation Orion by an orbiting telescope...So mysterious is the object that astronomers do not know if it is a planet, a giant comet, a nearby 'protostar'...a distant galaxy, a galaxy so shrouded in dust that none of the light cast by its stars ever gets through...The most fascinating explanation of this mystery body, which is so cold it casts no light and has never been seen by optical telescopes on Earth or space, is that it is a giant gaseous planet as large as Jupiter and as close to Earth as 50 trillion miles. If so, it would be the nearest heavenly body to Earth beyond the outermost planet Pluto. When IRAS scientists first saw the mystery body and calculated that it could be as close as 50

trillion miles, there was some speculation that it might be moving toward earth...the next step...is to search for it with the world's largest optical telescopes (Columbus Dispatch, pg 1A)."

After reading this, I began an investigation. I called several astronomers and Bob Dixon of the OSU radio telescope. They knew nothing about the mystery body. Also, for experience as a beginning writer, I wrote to several tabloids concerning the story as a news tip. From Globe Communications Corp. 2112 South Congress Avenue, West Palm Beach, Fla. (the address of Sun), I received, "Thank you for your recent query and for your interest in the Globe. Unfortunately, we are unable to use your material at this time." It was postmarked 29/2/84. Also from Globe., I received, "Thank you for your interest in the Sun! I'm sorry but we cannot provide further information on the discovery of a Jupiter-sized planet that was run in the Columbus Dispatch."

To my surprise the March 27, 1984 issue of the SUN, ran a front page "picture" of a mystery body with the headline: "Mystery planet heading for earth is giant UFO base." The article was titled, "Giant UFO base moving close to Earth." It gave the following information: A special orbiting telescope has discovered a giant space mass within a celestial stone's throw from earth that some experts think may be a UFO base -- or 'Death Star'--moving toward earth...the mass is about the size of the planet Jupiter...It emits no light that has been seen in any earth-

bound telescope, although now that the mass has been spotted, the giant 200-inch telescope at Palomar Mountain in California is straining to catch a glimpse of it....The mass is about 50 trillion miles from earth--just beyond our solar system's furthest planet, Pluto..."

"There is also a more sinister explanation,' says Dr. Rudolf Velmier of California's Institute of Psychic Space. 'The mass is a UFO base and it is heading for the earth. It is a sort of Death Star and we have been able to correlate data of UFO sightings suggesting that the objects are definitely heading for that part of the sky--just below the constellation Orion--when they leave the earth. This is a breakthrough we've been waiting on for years. We have all these UFOs buzzing around, but until now we had no idea where they were coming from or going to.' Dr. Velmier's organization is interested in contacting the Death Star and opening diplomatic relations with the aliens." This article also has a sketch of the giant UFO base (looking like a large plate-shaped flying saucer) heading toward earth.

So during all of this not only did I gain writing experience that they don't teach in courses, I may also have initiated a UFOlogical "urban legend." However, I haven't found out anything else about the planetoid since.

INTERVIEW WITH AN INFORMANT

This person (IN) was interviewed by Bill and myself on 6/11/93. During the interview, IN showed us a large notebook full of documents, drawings, photographs, and

other information. Many of the documents had Top Secret or Eyes Only stamped on top. IN claimed to be retired from the U.S. Air Force in 1988 having worked for the Sandia Laboratory after working at Wright-Patterson Air Force Base (WPAFB). IN claimed to have had no direct access to UFO information when he worked at WPAFB. The way IN had gained access to UFO information was by calling for a Top Secret document he had a reference to. He knew of the document and what its control number was. This caused a security alert.

IN said that, in general, the two largest operations for UFO research were at Los Alamos, NM, and Groom Lake (Area 51), NV. He believed that UFO research at Groom Lake began in the 1950's. (Another MORA Area 51 informant worked there in the 1960's and was unaware of UFO research there, but he did not have a need to know.) IN said that this research was based on cooperation between aliens and the US government. There are facilities at Los Alamos that do nothing but UFO-related research. A chief scientist there has done this work for 40 years.

There are reportedly two alien groups both of which come from the Reticuli double star system. One group is the short gray type and the other are tall so-called Nordic blonds. The blonds look human, but they are not. These groups live 1 light year apart, one group in the Zeta 1 Reticuli planetary system and the other in the Zeta 2 Reticuli planetary system. They used to be at war, but are now at peace. (However, research indicated that these two stars are actually "...separated by about a fifteenth of a light-year..." see R. Story, *Encyclopedia of UFOs*).

(The Reticuli star system is of interest because it was noted as the alien's star system using the Fish interpretation of a view that abductee Betty Hill presented under hypnosis as part of her reported experiences aboard a UFO. The Fish interpretation of this view showed that this area of the galaxy is highly unusual: "The fifteen stars shown on the map are all basically like the sun and could theoretically have planets like Earth. These are the types of stars some astronomers are currently examining in search of signals from alien intelligences...Most important, those fifteen stars on the Fish map are the only sunlike stars within a specific volume of space 48 light-years square and 32 light-years high...But when the analysis is expanded to three-dimensional space, the many remarkable features of the Fish map come into play...She built six three-dimensional models showing the relative positions of up to 256 stars, something that had never been done before. In doing this, a previously unknown plane of sunlike stars, from which the Hill map emerged, was discovered--a significant by-product of the research...No one in the world in 1961 knew where some of those stars would appear on such a map--there was no published data. (R. Story, *Encyclopedia of UFOs*)." It is also of interest that the gray's seem to be a classic alien shape e.g., Betty Hill's description, and the Nordic blonds seem to date even further back e.g., the George Adamski story of the 1950s.

IN said that these two groups of beings have told the US Government that they are the only group of aliens to travel to the earth. (IN told Bill in a phone conversation that other alien groups exist, but are unable to

travel to earth. He either couldn't or wouldn't say why they lacked this ability.) IN said that the aliens also told the government that no abductions were taking place. However, IN questions whether this is true. He is currently working a case that he believes to have high credibility. The person (C), who he believes may be communicating with the aliens, thinks these aliens are not telling the truth. She believes that the aliens are abducting people. She also thinks that other aliens may be here as well. IN also says that abductions tie in with the "gray identity," that has been here for 24 years. The government reportedly believes that the grays are not here at this time; however his communicant, says that they are here now.

IN reports that C does not feel she is totally human (like the people in MORA's previously reported Federation story). Since IN began investigating her, he has been subjected to phone harassment, such as low voices, noises, growling, and other sounds. IN thinks this harassment comes from the aliens, rather than the government. IN thinks this harassment points out areas of study that he should stay away from. IN reported in this context that the aliens are able to perfectly imitate individual person's voices. He has received calls from people he knows who later claimed in person that they had not made the call. IN said that people likewise have received calls from him that he didn't make.

IN reports that in 1986 President Reagan instituted a study of UFOs and alien abductions. IN believes that if abduction stories are true, then there is an increasing problem, because the visitors have been lying. If this is true the government is beginning to realize that

it does not know how to protect its people from the alien agenda, whatever it is.

IN reports that the aliens have made a big intrusion into the human genetic code, but that this intrusion is subtle, not overt. The long-term goal of this genetic intrusion is unknown. He claims that the experiment may have begun before 1939. (This is longer than the 24 years that IN reported that the grays had been here.) IN didn't know if the alien genetic intrusion occurred recently, or over evolutionary time.

Bill mentioned that a person he had talked to, reported hearing about a top secret human engineering research group at Los Alamos. IN seemed interested in this information.

IN said that the sperm and eggs of abductees are used by aliens. They may introduce an alien trait in a human genetic line and continue many crosses in this human line in an attempt to properly establish the trait in an unobtrusive way. IN also said the reason why aliens are reported to be humanoid in form is because of the weak nuclear force. The weak force supposedly is the life force and it determines the structure of living things. It causes DNA molecules to twist in the direction they do. In short, this fundamental force causes life-forms from many places in the universe to grossly resemble each other. (However a 6/15/93 New York Times article said the theory that the weak force is related to molecular handedness has "suffered a blow," because the weak force is too small to impart a bias in the handedness in amino acids.)

If all of this is true, the visitors might be producing a whole new

race. This new race might be loyal to them. If this is true, it is certainly a well kept secret. I asked if the body scans and sampling often reported by abductees could be used to reproduce a clone of the human abductee. I also asked if the neural activity of the abductee could be reproduced so that the clone would have the same memories and thoughts as the original person. IN replied that the aliens could not do this. He added that the scans were genetic scans. (However, given what we humans now know about genetics, it takes only one or more complete cells to completely examine a human genetically.) IN said that repeaters, those who have repeated sightings, may be people who are being genetically scanned.

I asked if people could be bred in such a manner that the aliens could control their minds. IN replied that they couldn't, but that the aliens can control people with implants. IN said that the government has examined implants. However they concluded that these objects were something that had been manufactured by the body, because human technology is insufficient to analyze them. IN claimed that the implants had organic circuits and are very high tech in nature. These organic circuits are too complex for government scientists to understand.

IN reported that the aliens had admitted to the government that they were behind the cattle mutilations where reproductive organs are removed. IN also reported that in some geographic areas the aliens are showing themselves off, such as over Mexico and Gulf Breeze.

IN revealed that Bill Moore is working on a report about the Bennewitz affair. IN did not know

where Bennewitz was at this time, but he thought he might have gone crazy and been locked up. IN said that the government asked Bennewitz to cooperate with them. When he refused the government decided to drive him crazy with "psychological warfare." IN claimed the government has done this to others, as well.

IN reports that the government is highly active in disinformation activities. He said that when disinformation is used the disinformant gives both true and false information, so that there is always some credibility to the information. This is done to lead investigators away from the truth. Disinformation is spread about many topics other than UFOs. The aliens like for the government to disseminate disinformation about their activities, because they then can do anything they want to while the government provides cover for them.

Two top players in the spread of disinformation are the military and the political "conservatives." He called these people "the bad guys." Opposing this faction are "the liberals." IN said that one such liberal is an international known political figure who he would not identify.

Those in the know about the alien presence on our planet operate in a compartmentalized environment. For example, IN said that Jimmy Carter did not learn about the alien presence until six months into his presidency. (Carter had reported seeing a UFO while governor of Georgia and repeatedly said that he would release the information if he became president. However after his election, he did not release any of the information). IN also said that George Bush chaired MJ 12 (it may have a different name now) when he was vice president. If any

of this is true, it is obvious that access to UFO information is carefully controlled, limited, and offered up on a need-to-know basis. Some people in the know, such as President Bush, apparently have more "need" to know than others.

The vault system under WPAFB (see "Fotos and Figures" section of this issue) is under study by outside investigators. These investigators may use engineers and a NASA overflight to examine the placement of vaults on the base. He reported that in one building a basement area exists with a tunnel and is blocked off with a vaulted door. Many of these vaults and tunnels were built during WWII because of the threat of a Japanese attack. Some are as large as 100 x 100 ft. and others have examining rooms, cryogenic storage, and "lung breathers." (The interviewers did not understand what lung breathers are. Possibly they were some kind of circulating fluid used for respiration.) Bill recalled a report from a retired WPAFB supplier about nitrogen and other refrigerants being regularly shipped to WPAFB. His informant did not recall the years of the shipments. IN thought such vaults were where alien bodies were once kept, although they weren't originally made for that purpose.

A tunnel was found on blue prints seen by IN. The entrance to another tunnel was through a bathroom. The area where vaults are located stretched inward from buildings 620 and 739. There may have also been vaults around buildings 167, 189, 640 and 653. Around building 653, there reportedly is an underground structure as large as a hanger. A large tunnel was under and attached the buildings 739 and 620. The alien bodies

reportedly were kept in a vault at WPAFB as late as 1982. They were then moved to Las Alamos.

IN claimed there are artifacts from a number of crashes, not just Roswell. The Russians have a program with the aliens like the US Los Alamos and Groom Lake. However, not much is known about it.

IN said there had been many aliens of the gray and Nordic blond types here. The aliens were in close contact and behaved cooperatively with the government. IN reported that at one time a Colonel had allowed an alien to live with him in his home for 3 years (~1949 to 1952). There are movies of this.

IN said that the crash at Aztec, NM did not take place. IN also reported that Bob Lazar had worked at the salvage yard at Las Alamos and that he was not a scientist. He may have had a secret clearance, but he did not have access to the things that he said he did, and he did not have a degree. IN added that Richard Doty deliberately disformed Linda Moulton Howe.

IN showed us computer drawings of alien (gray) heads, torsos, legs, arms, and hands. These drawings were reportedly used on the TV show "UFO Cover-Up Live." The copies that IN showed us had numbers and letters in the upper corners that he said did not show up on TV. One picture had what looked like "FTD-SYD, Veh Type WHDDD4" at the top left. FTD might mean Foreign Technology Division. "Veh Type" might mean vehicle type. The photos also had numbers at the right top. Another drawing appeared to have "FTD YP" "28 8100" at the top left.

The government had reportedly provided these drawings for use on

the show and decided to use the drawings rather than real photographs of the bodies. The alien's eyes that were shown had several different inner eye lids. (This is similar to what has been reported in MORA's Federation story and in *Alien Liaisons*, in that the people who are part alien/part human have double eye lids). The drawing showing the head looked like a regular gray head with large eyes, a small nose, and mouth.

These aliens were described as 3' 4" to 3" 8". There was a small amount of webbing between their fingers-toward the proximal end of the fingers and not extending very far out. Their lungs and heart were one organ. Their kidneys and bladder were also one organ. Their brain cortex was unusual because the visual area was in the front, rather than the back as with humans. Also, the brain was highly convoluted. Bill recalls that the aliens were shown with four fingers and four toes, but no thumb (This appearance is much like the aliens shown in the slides of Dr. Ludwiger, MUFON Symposium Proceedings, 1993 pg 257 and in other slides that were not reproduced in the Proceedings.) Another drawing showed what looked to be a stomach and intestines, but the caption said that scientists did not know what these organs were.



LUNG HEART

Bill asked about Psi Tech. and the

Mars face. IN had not heard of Psi Tech. He said that Mars did not have advanced life. This was because, although at one time it had oceans and water, it did not have them for long enough to make the evolutionary pattern that occurred on earth. There was not enough water on Mars during the time scale needed to produce Earth-like life. IN said that alien visitors put the face on Mars; there was no advanced life on Mars to make these structures. The visitors left these structures to tweak the human imagination. This is also why they leave crop circles and other such artifacts.

IN reported that General Exon signed the crash retrieval orders for a period of time. General Exon was scared about some of the alien activities that he became aware of. IN said that Exon has stated there is more material in custody than just that from Roswell. One object in custody looked like a crumpled dish pan. IN, when asked, said that human mutilations do not exist and he knew of no crashes in Ohio.

IN reported about some of his feelings. He said that the material he has become aware of over his years of studying the subject is amazing. He can hardly believe it himself. IN thinks most people will have a hard time believing it as the truth comes out.

CLOVIS, NM CRASH

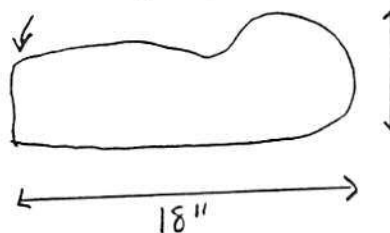

On 6/18/93, Debbie Valerio, Bill Jones & I investigated information from people living in several Ohio towns including Mansfield, Darlington, and Fredricktown. One person we interviewed, "Jake," had made several observations of UFOs. Jake had been in the U.S.

Air Force, and aircraft were a hobby of his. He was also familiar with military materials and military operations. Jake's experience started when he was young. One of his neighbors was an old man, who told him about the space people and about being visited by them. The man described these beings as "funny-looking men." Jake said that when they pointed at something it would come to them. Their vehicle was described as cigar-shaped. These contacts occurred in 1941, when Jake was young. Jake thought the man was around 70 years old.

When Jake worked on a SAC base while in the Air Force, he heard about a possible UFO crash secretly from pilots who had flown over it. The crash was reported to have occurred near Clovis, NM around 1957-58. The pilots thought it might have been a UFO. Jake and some of his Air Force "buddies" went to investigate. They drove to the reported site while on leave. It was southwest of Clovis. Soon after driving up to the site, they found a piece of grayish charcoal-colored metal. It was bent up on one end, 1/4 in thick, not aluminum, and light but strong. The metal was shaped like this:

Bent up end



It was about 18" long, 10-12" wide, and 5/16" thick. It weighed around 3-4 oz. at the most. The color all through the metal was the same. It resembled the color of

Teflon. They tried to cut rock with it, but couldn't; it didn't do anything to the metal. There were other smaller pieces of metal scattered around, some of which resembled confetti. When they threw the larger piece down, it didn't make a metallic sound, but made a thud. When the military personnel saw that they had the large piece, they told them to put it back in the exact place they had picked it up from.

***** CRASH ARTIFACTS *****

Jake secretly had collected some of the smaller pieces of the metal that was strewn around. Debbie and Roberta, both MORA members, drove all the way to Columbus, in a storm to bring them to Bill. The pieces are shiny, somewhat crystalline, and magnetic enough to stick together. The outside surface is dark. For a preliminary analysis, I broke a piece of magnetite and a magnet. The pieces more closely resembled the magnet than the mineral. Bill sent the pieces to a metallurgist. This metallurgist said that he thought they were an Alnico (aluminum, nickel, cobalt) permanent magnet. He plans to do a further analysis including mass spectrometry. Debbie and Roberta have had a preliminary analysis done (Appendix I). This analysis also pointed to an AlNiCo magnet. However, the amount of gold was unusually high. It would be difficult to prove either that such parts were not or were UFO parts, since the same materials may exist throughout the universe. If the metallic spectrum is exactly that of a known alloy, then probably the crash is of an airplane. We will have more detail in the next issue.

Earlier in his life (~fall, 1956), Jake had observed a UFO from a T-33 trainer, while flying with a pilot friend over northern Ohio, and Lake Erie. He and the pilot had been interrogated twice by the military after the sighting. Jake believed that the second interrogation was by people from outside the base. They told him that what he thought he saw didn't happen. This sighting was interesting for another reason. Jake drew a picture of this UFO. This picture closely resembled a UFO drawing presented during the 1993 MUFON Symposium (Dr. Ludwiger):

Jake reported seeing another UFO over NM. Jake and the pilot he was flying with had both reported UFOs previously and been told by authorities that they hadn't seen anything. Because of this, both told each other that they weren't seeing anything. They did not report the sighting.

MANSFIELD, DARLINGTON, AND FREDRICKTOWN SIGHTINGS

MANSFIELD - On this 6/18/93 trip, another person was contacted. This person not only had an ongoing experience of possible

contact with alien beings, but also may have taken camcorder photography of possible UFOs. The person was keeping a diary of events. (This person is being investigated by others.)

FREDRICKTOWN - We also stopped at the home of another person, who had seen an object in her yard (*Ohio UFO Notebook* 3/93 pg 29). She had been very close to an object in her backyard which had a "cockpit" area in which three hooded figures were sitting. When her headlights illuminated the object as she drove into her driveway, it lit up and was bright enough to light up the whole yard.

Bill remembered the way to her home 17 years after the initial investigation. She was there when we stopped in unannounced. She was now in her 80's, quite healthy, and still remembered the experience vividly. She said that it was not the kind of experience that one forgets easily. A detail that she mentioned which wasn't reported previously, is that after the sighting, she and a neighbor looked over the area. They found some scorched tree leaves where the object had been.

DARLINGTON - We next questioned most of the residents in Darlington, OH, in reference to a case that took place in 1953 (*Ohio UFO Notebook* 8/91 pgs 15-17). As described in this article, Mr. William English claimed that he saw *Blue Book Report No. 13*. It told about a case where in 10/53, a 13 year old boy was carried off by what looked like little men from a fiery looking object. Within 48 hours after they reported this, the Air Force decided that the family should be relocated. The parents were loaded into Air force trucks

and moved. During our present investigation, one woman told us about hearing stories concerning little green men (which is what aliens were called at that time) and UFOs landing in a nearby woods. (Darlington is very small. This woods was within a few hundred feet of the town's center.) She heard these stories from kids in the neighborhood. This was around 1956, which is close to the time of the Darlington report. Even though we asked at only 5 homes, we heard another story about UFOs. The brother-in-law of a man we questioned had seen a UFO land near him many years before. This occurred very close to Darlington.

UFO REPORTS FROM THE NORTH COLUMBUS AREA

REPORT 1. This report was investigated (12/4/94) by Bill Jones and I, who both traveled with witness 2 who reenacted her sighting at its location. The witnesses were interviewed separately.

This sighting occurred in the area around Routes I-270 and I-71, southwest of Westerville, OH. It happened on 13/10/92 at around 8-8:30 PM. The call was logged at the National UFO Reporting Center at 5:15 PM. The witnesses, two mothers and their two sons, were driving home after seeing a movie. Near one of their homes, the four looked up from in their car to see an object, which appeared to be in the west just over the trees at the edge of the apartment complex where our witnesses lived. (We investigated this sighting at nearly the time in which it

took place. At that time of the evening, just after dark, the outside area of the complex was almost deserted.) At first, the witnesses thought they might be watching a plane crash.

Witness 1, interviewed separately from Witness 2, said that, when first seen, the object was hovering and looked like an organish-yellow circular glow. It had lights around it. Suddenly it traveled at a high speed to the north and then stopped over another part of the apartment complex. They noted that the object appeared triangular at this point.

Witness 2 described the shape of the object when first seen as dark and oblong, surrounded by white light. There were 3-5 white lights associated with it. It appeared to be about 8" at arms length. They stopped the car when the object was first seen and all four of them observed it. The object appeared to be around 2-300 ft. away. They then continued driving toward the apartment and parked in the space near the building.

At this point, all of them wished to get out of the car to further observe the object. However none of them were able to open the car doors. They were also unable to roll down the car windows. After a few moments they had no trouble opening the windows or doors. As they exited the car the object appeared to split into several smaller objects. While the object was still in view, the driver, witness 1, rushed to her apartment and immediately called Port Columbus Airport which is nearby. The control tower informed her that no aircraft were in that area at that time. The airport notified the National UFO Reporting Center in the state of Washington. This

witness then called the Columbus police and Don Scott Airport, also located in northern Columbus. She made all of these reports while the object was still in sight. The police said that there was no helicopter in the area. Don Scott Airport reported seeing nothing. It appears, therefore, that what they were viewing may not have been a standard aircraft, because one or more of these agencies should have been aware of an aircraft in that area. (Witness 2 lives near the guide slopes of both Port Columbus and Don Scott and is familiar with low flying aircraft.)

Witness 2 also reported that they were unable to open the car door or open the car windows. She said that the object had an oblong hot-dog shape with 3 bluishgreen flashers. She saw 5 white lights in a row. It then shot up into the sky and came back. She reported that the two boys ran through the apartment from the back door and out the front to the apartment of a neighbor who lived across the street to the north. By this time the object had changed into balls of light. The witness said that as she stood outside near the apartment, one such ball of light made a close swoop (~ 20 ft. at the nearest) by her. The boys contacted a neighbor, and he might have also seen some of the balls of light (We did not contact the neighbor because we investigated somewhat carefully--witness 1, who reported the event, had changed her mind.)

At various points in the sighting, the balls of light later lined up in a row. At one point, the witnesses saw three of the balls of light come together. During what was most likely this period of time, Witness 1 said that the object gave a flash of light, shot off, and was gone. The other lights then

appeared to come in together. Some resembled search lights. (Witness 2 had described these lights. At one point they lined up in a row. She said that unlike regular search lights that originate on the ground and go up, these lights appeared to come from above.)

Their boys appeared to have lasting reactions to the experience. Both were scared and have, to some degree, remained so. One had strange dreams and insomnia. He wanted his mother around all the time. One of the boys was so affected that some time later he went to a school counselor. This counselor was negative about the existence of UFOs. One of the boys had been teased by friends that he told about the experience. Witness 1 reported that her dog behaved in a strange manner. Both witnesses thought the sighting had lasted around 45 minutes. Neither wanted us to talk to their sons. Both felt that the boys were sensitive about the experience and about UFOs in general.

Both witnesses have had other sightings. Witness 1 had experienced several possible "supernatural" events. Witness 2 had seen a small ball of light follow a car that she and a friend drove while they traveled from around the Graceland Shopping Center, which is also in northern Columbus, to north of Worthington, OH. This occurred several years before the sighting being reported here.

REPORT 2. Investigated (2/27/93) by Bill Mumma, Bill, and I. The witnesses, two sisters, were interviewed together at the location of the event (northwest of Delaware, OH). Bill M. recorded parts of the interview on cassette. I

camcorder the interviews at the location of the event.

This event happened in 1981 in the fall (~September) at around 11:30 PM. They lived in a home with their parents in a rural area north west of Delaware. Coming home from a high school football game, they pulled into their driveway. Looking to the south, both sisters saw an object about 1/4 mile distant in a 15 acre pasture. One sister believed the object was dark and the other sister thought it looked like a fireball. Both were astonished and sacred; they just sat in the car and watched.

One of the sisters saw two objects, one located behind the other. She observed that a ramp appeared to come down from one of the objects. Although the other sister was in the car at the same time, she did not see this. Both ran into the house to get their mother. All three saw one object flying away. The sister, who saw the two objects, said that she thought one object had been behind the other as they left. She said she thought that she saw the ramp and her sister didn't because she, somehow, was prepared for a more intensive experience.

The family had experienced other UFO events. At one time several family members observed a car-sized ball of pink plasma hovering over their front porch. It was only about 10 ft. above the ground and close to the house. Several months later, they had observed a similar ball behind the house.

There is a pond and woods west of their house. The sisters said that one of their brothers, who was younger and lived in the house longer than they did, had a room which faced this area. The brother

had reported several sightings of objects over this area. The sister, who lives in Mansfield, OH, has been experiencing a continuous series of apparent contacts. Their father and an uncle are also experiencing some form of contacts.

The family is influential in the community. The sister, who made the report, is a model. Her grandfather is one of the inventors of the xerography process. He is listed as such by Battelle and both sisters believe he holds a patent on a part of the invention. Their father was the founder of a computer company that was heavily advertised in the Columbus, OH, area. Lastly, an uncle designs satellites and has worked on the design for the F14 Tomcat.

AREA 51

The information in this article is from a person (IN), who lived and worked in Area 51 and also at the Atomic Energy Commission (AEC) atomic test site in the early 60's and from an old area map. IN had had a Q clearance, which is an AEC clearance that is slightly below top secret. (A drawing of the test site using his information is shown at the end of this article.)

Security - The way Area 51 was entered at that time was from the Test Site Road. This turned off Rt. 95 west of Indian Springs. It headed northwest and then north east into Groom Lake. (It passed by bomb craters. One was Sedan Crater where the hydrogen bomb was tested.) Mercury, Nevada was located near the Rt. 95-Test Site road area. After a security check, IN simply drove his car into the area. IN has no photographs and added that cameras were not allowed in the area. Area 51 was under Air Force security. The

general security classification in the area was above top secret. No records were kept of transactions. The Spotted and Pintwater gunnery ranges for Nellis AFB were also located near this area. IN felt this would aid area security.

At the time IN worked there, the SR 71 was being tested. IN said that when it flew, people were told to stay indoors so that no one could see it. It was highly classified at that time. The SR 71 was housed in a hanger. People were not allowed to look inside. IN reported that pilots from the private company that built the plane, taught government test pilots how to fly it.

Location - Area 51 is located right at Groom Lake. This is because the lake bed is dry and flat. IN said it could almost be used as a runway by itself. IN had not heard of Area S4 and did not know of UFOs in the area. Airplanes were housed in hangers in the area. IN did not think that there were extensive underground works or tunnels in this area, adding that it was a dry lake and might have been hard to tunnel in.

Tunnels - However, numerous large underground facilities and tunnels were located in the test site area. Areas that had tunnels included Pahute Mesa and Yucca Flats. These areas had straight drill holes and drill holes going at angles. Underground testing was done here. Atomic bombs were flown in at Indian Springs AFB. Bombs were first tested at the Frenchman area and later, after this area became contaminated, testing was done at Yucca Flats. IN didn't know how large the largest tunnel would be, but said that they were large enough to contain an underground atomic blast (their

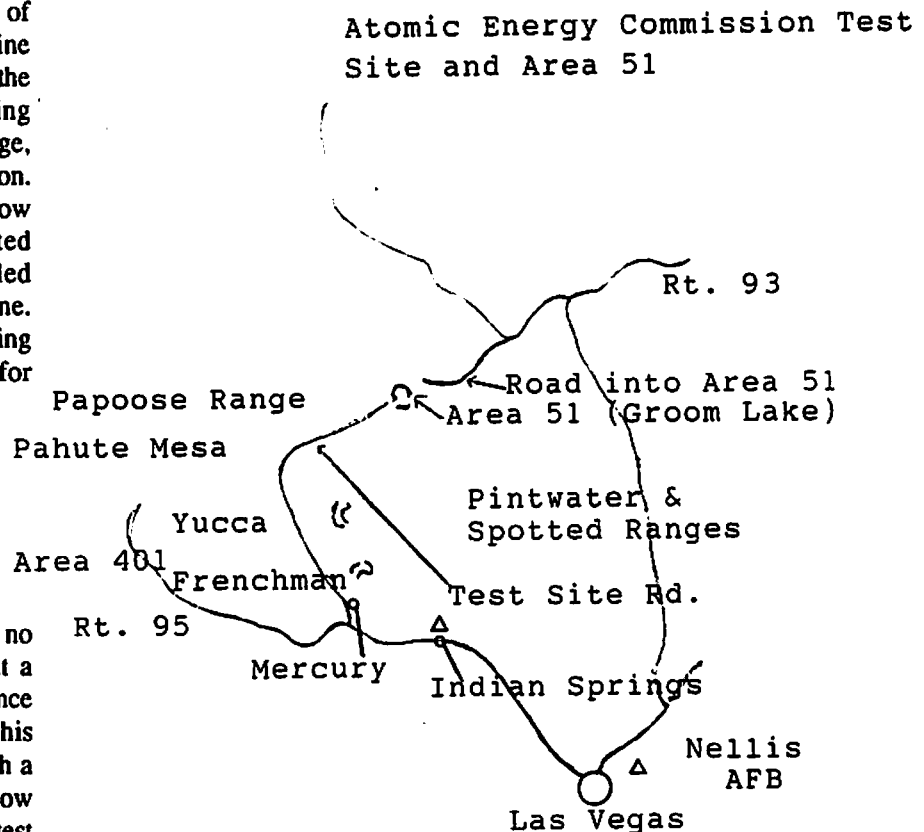
purpose). The tunnels were generally dug with mining equipment. Some of the tunnels in the area were entered by "dinky locos," or small mining locomotives. Generally there were buildings, sometimes trailers, atop or near the tunnels.

In Area 401, near the west end of the site, the doomsday machine was stored. This was located in the Mechanical Assembly Building (MAD). This building had huge, thick walls to contain the radiation. The doomsday machine was a low flying missile which emitted "dirty" radiation that killed people, but left buildings alone. Area 400 was used for the testing of nuclear powered engines for submarines.

Although this person had seen no UFOs himself, he recalled that a friend of his had told him that once a UFO made a low pass over his home. This friend went out with a gun and shot at it. IN didn't know whether his friend lived on the test site then or not.

Area 51 may also be the world's largest Superfund (toxic waste) site. The atomic testing area would be contaminated as would be many of the tunnels. Area 51 itself would be downwind of the site and might have some contamination. Many other such sites, which would have been much less contaminated e.g., Hanford, WA, and Fernald, OH, and Wright Patterson AFB are now considered federal Superfund sites. The fact that the AEC test site is not considered a Superfund site, may indicate its continuing importance.

DEFENSE CONSTRUCTION AND SUPPLY COMPANY (DCSC)

DCSC is located in Whitehall on the east side of Columbus, Ohio, on East Broad St. near 270. I visited this facility in 1992. Although, it is secured, one just

needs to state the name of a contact person in the facility at the gate to enter. The contact person is called from the gate. I walked unescorted to meet her. On the way back, I

was able to wander around the facility some and did not feel that I was being observed. (Actually, I had accidently parked my car in the secured area, before anyone noticed) It is a very large facility used to house and distribute defense supplies. It has been mentioned in relationship to several UFO events

1. The first such event was mentioned (*The Roswell Report*, 1991, pgs 96-7) in an investigation by James Moseley. A DCSC employee, in late summer 1952, reported that she had information about a UFO that crashed north of Columbus. A few days later an alert was sounded at the installation. She and others were given a briefing where she was told that the alert was related to the fear of an attack by UFOs following the recovery of such a craft. The woman said that the UFO had gone through DCSC on its way to Wright-Patterson Air Force Base (WPAFB). Also, rumors circulated through the center about the recovery of five-foot aliens that looked much like humans.

2. Another event associated with DCSC was reported by MORA member and one of the Roundtown UFO Society (RUFOS) founders Pete Hartinger. He had been given the information by a close relative. The person was interviewed separately by Pete and myself. He was very credible, he was a decorated war hero, having served in the Pacific theater during WWII. He retired as a, DCSC supervisor. The sighting took place at the Columbus Army Depot (which is now known as DCSC) in the early 1950s. It took place in the daytime. He was standing on the dock of one of the warehouses with two other men. He excitedly pointed out to the other men when he saw

an object swoop down over the warehouses. It came in so low that he thought it had come out of a hanger at the nearby Curtis Wright aircraft manufacturing plant (now North American). He remembers telling the others that this object must be ours, because it was flying so close to the ground. He told his wife about the sighting later that day, and she remembers this.

Until a few years ago, he still thought that this object was a US device. However, after studying different sighting reports, he now has doubts about this origin. He recalls that when the TV series, "Voyage To the Bottom of the Sea," was on that the small craft (shuttle sub) they launched from their submarine resembled the object he saw. The object was circular, but had two fins on the rear. He believed it was 5-700 ft. in altitude during various parts of his observation that lasted around 3 minutes. The object was grey and its apparent diameter appeared as large as airplanes coming in for a landing at nearby Port Columbus. He could not estimate its actual size. He just recalls viewing the underneath part of it and not the top. He has never seen an aircraft that resembled it.

It flew slowly down the main street of DCSC and then turned east and flew away. There was a vapor trail behind it. He does not recall a noise. It turned before building 42 and 41, behind some storage sheds. He was standing directly in front of it when it first came down the street. Several other people saw it at the same time, but he doesn't remember their names.

Soon after this, he believes it was the next day, one of the buildings that had been unsecured, suddenly became highly secured. The

windows were blocked and no one was allowed in. Part of the outside area was roped off. He also thought that this event might have happened at around the time that the possible UFO events reported by J. Moseley took place. He thinks (or heard a rumor) the object may have buzzed DCSC, because of reported UFO artifacts in storage in there.

3. Another person (interviewed by Pete and myself) reported witnessing a large UFO-shaped object being carried in a flat bed truck in a military convoy down Broad Street in Columbus. Apparently this was rumored to be a UFO being taken from DCSC to WPAFB. This probably occurred in 1954. The object was covered with canvass and was accompanied by motorcycle police.

4. Another recent MORA informant, who reported that she worked at DCSC, said that several high officers (generals), who worked at the facility, showed films about UFOs. The films were chiefly of UFOs in flight through mountainous areas. She also recalled information being discussed about alien babies.

This informant has stated that psychological warfare is used on people the government wants to discredit. They may end up in asylums. The informant reported hearing about a 1941 UFO crash. (This information agrees with information from Pete Hartinger about a 1941 UFO crash.) This person also reported that Neil Armstrong has an interest in UFOs. (Similar information came from several other sources.)

An unusual result of *Project Bluebook Special Report No. 14* is information about the geographical

distribution of U.S. UFO reports. As early as 1953 UFO investigators became aware that UFO reports were concentrated around certain "critical areas." Twelve such strategic areas were picked by the project scientists. One of these areas was the area around Dayton, OH. Other people have said that UFO reports are concentrated around the Dayton-Columbus, OH area. These areas of concentrated reports appeared to be associated with areas of large aircraft or military activity; however they did not appear to be caused by misidentifications of aircraft. It is unknown why UFO reports would have this distribution. One might speculate that a relationship might exist between the military installations in the area such as WPAFB, DCSC, and other military and aircraft installations and UFO activity. In addition, WPAFB was associated with UFO study from the initial UFO reports e.g., Project Bluebook.

This information is unverified and merely reported in the event it ties in with any other investigations. However, DCSC is a large, highly secured area, that is within less than 100 miles of Wright-Patterson, and might be used for the purpose of storing or securing objects that have fallen from the sky, on their way to areas such as Wright-Patterson, where they might be analyzed.

TID BITS

EXAMPLES OF GOVERNMENT DISINFORMATION

The government creates, distributes, and promotes disinformation about a variety of subjects other than UFOs. Recent disinformation

in the news includes reports (*The Sciences* 3/4/1993 pgs 16-19) about radiation contamination found in Utah, resulting from the nuclear testing in Nevada: "Women suffering the effects of radiation poisoning--loss of hair, badly burned skin--were dismissed from local hospitals, diagnosed with 'neurosis' or 'housewife syndrome.'" Another example of this is the sailor, Clayton Hartwig, who was blamed by the Navy for causing the explosion aboard the USS Iowa (*Columbus Dispatch* 6/24/93 pg 8A).

A further example involves military personnel, who took part in several nuclear tests: "They were on their hands and knees with their eyes shut. Still, the light was blinding, the heat burned the clothes on their backs, radioactive debris fell on them. Then with the mushroom cloud still in the sky, they were marched in formation to the glistening crater where the bomb tower had stood....The Marines' mission was to determine whether soldiers would still take orders after being put next to an atomic explosion...'We were good Marines, we did what we were told...' (*Columbus Dispatch* 6/24/93 pg 8A)."

MISSILES FROM MARS TO EARTH

The *National Geographic* (5/93) reports in an article entitled "Missiles to Earth from a Crater on Mars," that Martian rocks have turned up in Indiana, Brazil, the Antarctic, France, Nigeria, and Egypt. Scientists believe they might have found the crater on Mars that is the parent of these meteorites. This indicates that there may well have been exchanges of materials between some of

the planets of our solar system, which means that the possibility exists that spores or other life forms may have been exchanged as well.

MYSTERY VIRUS IN NEW MEXICO

Science (6/11/93) reports: "...US health officials tentatively fingered a member of the hanta virus family as the cause of an outbreak of a flu-like illness blamed for the deaths of seven people in New Mexico and Arizona. Now comes the bitter irony: for nearly a decade the U.S. army maintained a program for studying just such a virus...Korean hemorrhagic fever, caused by a hanta virus, killed nearly 400 U.S. soldiers in Korea in the 1950's. About 10 years ago the army began studying the virus... and in the late 1980's expanded the work..." Is the New Mexico virus the Korean form? How did it get from Korea to New Mexico?

LITTLE GREEN MEN

Science (7/9/93 pg 158) has an article about era of the Marsian "Little Green Men."



ROSWELL, THE B-29, AND THE FUGO BALLOONS

Many reports about Roswell say that a B-29 was used to carry crates from Roswell AFB to Fort Worth, TX. At least one of the crates was reported to be approximately twelve feet long, five feet wide, and four feet high. Four armed MPs accompanied this crate.

On 6/11/93, Bill and I checked this story out in one way by measuring several B-29's or modified B-29's at the Wright Patterson AFB museum. One B-29 fuselage on display has been cut open so that people can walk through it. These measurements confirmed that such crates should fit into a B-29, although it would be a very snug fit. Some reports say there were two such crates. This would also be possible. The two bomb bay areas are of the same size, one aft and the other in front of the wings. Some reports say these crates were specially made and unmarked. Possibly these crates were built on the spot to fit into this airplane, which is not normally used for carrying cargo.

Reportedly the plane flew at a very low altitude, which suggests that the crate carried something other than inanimate debris. However it might have flown at this altitude because of having the MPs on board in the unpressurized area where the crates were stowed.

Reports that a crate of this size could be carried by an B-29 is consistent with the size of the B-29 bomb bay compartments. The reports say that each crate had to be checked for size and the crew had to know which crate went on which plane. Several crates were also reportedly loaded onto C-54s. Obviously, such crates should

easily fit into this plane.

At the Wright Patterson Museum there is a display of information and photographs of Japanese FUGO balloons. The display includes balloon parts and a sample of the rice paper the balloon was made of. Some people think the Roswell object was one of these balloons. The display noted that these balloons were last released in 1945. The largest of the Roswell crates was reported to have been twenty feet long, four to five feet high and four to five feet wide. The loading took ~ 8 hours. It does not appear that there would be enough debris from a crashed FUGO balloon to fill several crates of this size and take this long to load. It looked to me as if an entire FUGO balloon could rapidly and easily be loaded into one of these crates, with room to spare.

SYNCHRONICITY - THE MORA EXECUTIVE COMMITTEE

The first six members of MORA later became its Executive Committee. These people came together at random from a variety of backgrounds (social work administrator, computer systems analyst, pilot, engineer, attorney, and toxicologist). However, after meeting they discovered several interesting similarities in their backgrounds.

The UFO experience of one of these people was described in the 5/92 *Ohio UFO Notebook*. This person (A) was born in Marion, OH. Her first recollection of a UFO experience occurred there when she was a child. She remembers a lucid, recurring dream where she would stop at a field on

her way home from school. A large hole would open up in the ground. The hole was black and she would go to its edge. She then would step inside. It had smooth walls. She would come to a waiting area and wait. Eventually a black shape came and would lead her down a hall to a room where she would attend a class.

Other experiences include ones (all but the object were remembered under hypnosis) that occurred (1964) near the Delaware Dam, north of Delaware, OH. Several miles south of this area is Perkins Observatory, which once housed one of the largest optical telescopes in the US. On its grounds, also, is Big Ear, a radio telescope now used in the Search for Extraterrestrial Intelligence (SETI). During a trip between Columbus to Marion, she turned into a road near this observatory and saw an object that was round with a dome on top. She at first believed she was viewing the telescope, but later remembered being taken inside a dome-shaped UFO. This object had a domed top and a row of windows around the middle. The floor inside was a glowing translucent surface. The walls glowed a white pearlescence.

Another of her experiences occurred when she was living in New York (1965). She awakened one morning from having a dream in which a large black figure was leaning over her while she was in bed. The next morning she started to tell a neighbor about the dream. But before she could say more, the friend told her about her own scary dream. Her neighbor's dream was exactly the same as her own. Under hypnosis, she remembered an abduction of a number of people. People from all over the apartment complex were gathered

together in the courtyard. They were all in a trance and were being taken up one at a time into the object. Black figures were around the courtyard. She also reported (in 1983, before either Missing Time or Intruders was published) that a tube was inserted into her vagina and a smaller instrument into her nose. She felt she had been tagged.

She took no action about these events until she attended a lecture by Ray Fowler on the subject of UFOs. He set up a meeting between her and Joe Nyman. Later her experience was investigated by Joe Nyman and Budd Hopkins. It may have been one of the first reports of a multiple abduction and possibly of the insertion of something into the vagina and the nose. She thinks that the investigators may have been cautious about her report, because of this.

Her report is also interesting because it turned out that another member of MORA's Executive Committee (B) was also born in Marion, OH. In fact, during her childhood, she had lived about 4 blocks away from the other member and had been in the same class as the other member's sister. This member had experienced a strongly recurring dream for around 5 years during her childhood (in the 1950s) that she would go out of her house to a vacant lot and look into a dark hole. She also experienced an underground classroom situation with other students. (At that time computers did not exist and she didn't understand this experience. Using today's information, she recalls her experience as sitting in front of PC computers and looking at video screens.) The park she played in as a child was the park where the other member had her first possible abduction experience and recalls

being taken underground.

B also remembers that she and her sister woke up to see a figure looking down over her bed. They screamed in terror for their parents. She also recalls that when she was age 2-3, she saw something that had large eyes in her bedroom. She recalls a vivid dream of standing outside in her yard as squadrons of UFOs passed by. In the 1960's, B recalls seeing a UFO near the Port Columbus Airport and having a period of missing time associated with this sighting. Both A and B seemed to feel they had experienced a teaching situation associated with the hole in the ground. Both seemed to have this experience associated with large figures, that may have been black.

Another of the six, had an early childhood sighting of a possible UFO, and a long possible close encounter during the 1960's in MA with an object which had windows and appeared to have glowing inner walls or a glowing floor. These recollections were also investigated by Budd Hopkins and Joe Nyman.

Three Executive Committee members have scars on their calves. Three are possible abductees. Another had a possible sighting of a gray. Two have had no personal UFO observations. Another had worked at the "Big Ear" and Perkins telescope complex and had been investigating UFO reports in that area.

Frank (Korean War RF 4 pilot) and I (DIA) have worked in intelligence. Among other similarities: before meeting, two members once lived across the street from each other in Columbus and before meeting, two members attended the same class at Ohio State

University and three had worked at Battelle Memorial Institute at the same time.

THE GUARDIANS

A possible abductee/contactee was interviewed by Bill and I on June 13, 1993. Her first memory of a possible abduction experience was around age 3, when she remembers trying to reach up to turn the door knob of the front door of her parent's home. She wanted to go out to see a UFO that she somehow knew was near or above the house, but her family didn't want her to go. This happened in winter. She knew that aliens were here at this early age. She remembers something huge gliding over her house. She grew up near on a farm. She always felt like there were two of her, but she tried to fit in and be like everyone else. She reports that she can see auras and occasionally into other dimensions. When she was a child playing house, she heard a buzzing and thought it sounded like all knowledge and wisdom was available to her.

She remembers Sunday dinners at the family farm with her family and friends when she was a child. She remembers a round ship that would sometimes land in the field nearby. Whoever arrived on these ships could turn people off so that they appeared to be frozen in time. The occupants of the ship would take either the children or the adults into the ship, and then turn the other group off for a while. She doesn't recall the inside of the ship. There may have been some type of learning experience or class that took place. She recalls some of her family talking about this, when she was a child. However, her family does not want to talk about this now. Many of the adults who were present are now dead.

were present are now dead.

She remembers a face and applies the term "guardian" to this kind of being. The being told her to look at its face and remember it. It resembled the face in Communion, the book by Whitley Strieber. The eyes scared her at first, but she thinks the eyes saw all of eternity and all of the changes humans are on the threshold of.

The skin of the aliens she has seen reminds her of grayish-tan clay. These aliens were about 4'11," which is her height. She thinks they have always been here and that the end of time as we know it is coming. When this occurs the foundation of religion and government will crumble.

Bill asked her to further describe the aliens she has met. She replied there were two main groups. The first are the gray-type. The other group is what she termed "the golden ones." They are tall, slender, and have shoulder-length hair turned under like a page boy. They also have beautiful blue eyes and wear a long white robe-something like a monk's habit- and a gold belt, with a golden hem. They have blond hair and bronze-colored skin that appears as if there were a "fire" underneath. Their hands have long slender fingers. She said they seemed "perfect."

One time when she was young, she reported playing with a toy dog in the ashes by a pot bellied stove. One of the golden ones asked her why she wasn't in school. She replied that she was too young to be in school. The being then took her to some kind of school. When he brought her back he told her that he had branded her. A marking appeared on her left hip that resembled an alien face. He told

her that it would identify her from then on.

Another type of being that she barely remembers is what she calls "the little dark ones." They are kind of purplish dark and around 2" tall. She has fear of them and wants to be placed under hypnosis so she can learn more about them.

IS MORA UNDER SURVEILLANCE?

When the movie of "Intruders" was shown on TV in 1992, several members of MORA appeared on the local Columbus, OH, CBS affiliate news show. The members talked about UFOs in general and MORA in particular. Barb talked about her personal experiences. She works for LifeCare Alliance, an organization that distributes meals to people who are shut-in. About a week after her appearance, she received an envelope in the mail addressed to "Live Care Aliens." The envelope, which contained legitimate work related materials, was mailed from a government social service agency in Washington DC, possibly the Department of Human Services. It was not from an individual in this agency.

At another time, Bill and Becky were having a daytime phone conversation from their respective places of employment and the subject of mutilations came up. When Bill said the words "human mutilations," the phone went completely dead. In a similar vain, from 1984 (starting around the time I first reported my own past observations) to 1992, I received a continuing series of phone calls, where the caller would leave the line open for around 45 seconds, or longer, and then hang up.

On 6/15/93, Frank, Joe, and Bill were on channel 62 live for an hour 7-8:00 PM, on Phyllis Ransom's call-in talk show, "Profiles." This low-power channel is little advertised and probably has a very small audience. Frank's phone number and address were flashed on the screen at the end of the show. At around 8:20 PM, Frank's family saw a "Huey" helicopter come in from the west toward their home north of New Albany, OH. It appeared to be black and they were unable to see markings. They noted the slow wish-whish-whish sound of this kind of helicopter. The helicopter, at about 100 feet altitude, hovered near the house and pointed its front end right at them. Staying in this position, it circled the house three times. This maneuver scared them, because the helicopter was in a firing position. It then flew off to the east.

The following events are also reported for the record; however these instances are probably simple coincidence: There have been numerous UFO reports in the area around Delaware, OH. I have investigated and published information about a number of such sightings south of Delaware near the Alum Creek Reservoir (e.g., OH Jr. Sci. 87(1):24-26 & MUFON UFO Jr. 5/86). The area north of Delaware, OH, by the Delaware Reservoir, is near the location where a MORA executive committee member had several encounters. In addition, a recent investigation was made by Bill Mumma and myself on 2/27/93, which is mentioned in "UFO Reports from the North Columbus Area." Immediately after this investigation a UFO sighting (3/4/93) took place north of Delaware (Ohio UFO Notebook, 7/93, pgs 12-13). The experimenter

said that she saw a near-by UFO in the middle of Route 23 about 60 ft. away from her. An odd circumstance that related to this sighting is that the witness mentioned the sighting to an Ohio State University psychology professor from whom she was taking a class. The witness reported that this professor immediately left the room claiming that he would call Wright Patterson AFB (WPAFB). When he returned, he told the witness that WPAFB told him there had been several sightings in that area. The professor now denies that he did this. It is hard to imagine that WPAFB received such reports. However, if it did, the government's ability to obtain UFO sighting information is better than ever imagined.

Frank and Barb investigated a sighting near Troy, OH (*Ohio UFO Notebook* 12/91 pgs. 44-45). Here a man saw a green fireball appear to crash. About a month later, he and his daughter saw a possible close UFO in the same area. His daughter saw a green flash and the object disappeared. The morning after the sighting, a flight of five green military helicopters came out of the same area. On 2/10/84, I reported my previous possible UFO sightings to CUFOS. They sent me report forms and on 2/23/84, I began to fill them out. On that day, I had a daytime possible UFO sighting that lasted around 20 minutes. I had 4 other witnesses, who also made reports and were unable to identify the object. The witness are all PhDs and 4 have been or are university professors (*OH UFO Notebook* pg 2, 4/92).

On 4/16/93, an advertisement (with my home phone number and MORA's post office address) for UFO informants appeared in the

Skywriter, the Wright Patterson AFB newspaper. On 4/18/93, I observed an extremely low elevation airplane fly very close to my rural house. This was a large aircraft, possibly a C-130 cargo plane, and it looked as if it were quite a bit below the 1000 ft. elevation above which aircraft in this area are expected to stay. I would guess it was 2-400 ft. in elevation. I contacted a cousin who lives nearby and is the local fire chief. His wife reported that the aircraft had also flown over the firehouse (directly west of my house) and several firemen had seen it. They too could not believe the low altitude it was flying. They reported two aircraft with camouflage paint. Although a craft at this low altitude does not stay in sight for long, I managed to camcord it briefly as it flew away. On 4/23/93, Jane, the source of the Federation story, spotted what may have been a similar low-flying aircraft, near

Routes 23 and 42 north of Delaware (near the area where the 3/4/93 sighting and the other previously mentioned observations took place).

Later other MORA members noted that the National Guard normally flies such aircraft at low altitudes over this area on training missions. Although this may be a normal practice in some areas, none of my neighbors, nor I had seen a similar craft fly at that altitude previously. The airplane that I saw was less than 0.5 mi. from the Alum Creek Lake, a highly used public recreation area. Such maneuvers as these extremely low levels would appear to be too dangerous near these large numbers of civilians. Also since there were two airplanes this was a planned maneuver, rather than an individual "hot shot" pilot.

In the fall of 1992, MORA held an

observation night at my rural home. After dark, we began to hear helicopters, which sounded as if they were circling at a distance and coming toward us. Eventually we saw four helicopters flying from the northeast to the southeast in formation. This is somewhat unusual, because during the last 14 years of living there, I have only seen such a formation of helicopters travel through the area at night two other times. There were five in this formation (These flights were distinctive, because each of the five carried one bright, non-blinking, red light.) I also recall (other than holiday flights) only three daylight sightings of formations of two helicopters. I am outside quite a bit.

CIA, UFO PHOTOGRAPHY, AND TUNNELS

PHOTOGRAPHY - In 1968-9, I worked for the Defense Intelligence Agency (DIA). At that time, I believe I recall that the DIA was informally a branch of the CIA. Such divisions made the CIA appear smaller.

I had code word security clearances that were above Top Secret. One of the code words for the photography that I used was "KEYHOLE." Although this code word may still be secret, it is now in the public domain (e.g., *America's Secret Eyes in Space*). This book describes the program as follows: "The history of the KEYHOLE program is a history of one of the most significant military technological developments of this century and perhaps in all history....The photo-reconnaissance satellite, by dampening fears of what weapons the other super-

power had available and whether military action was imminent, has played an enormous role in stabilizing the superpower relationship." Much of this is still classified, "And though documents concerning such events may someday be declassified, present-day secrecy can severely limit access..."

In 1968, I was working in a section called Air Order of Battle. It was in the Soviet/East Europe Division, Eastern USSR Branch. Our activities including identifying and recording (targeting) the flying objects viewed on the KEYHOLE photography of the area. As I recall, I worked with a civilian GS-13, an Air Force Major, and two other civilians. Our work involved identifying all the flying objects over the area, such as aircraft and missiles, for each incoming mission and then making a report to the CIA. The CIA was the recipient of all of our reports, so far as I know.

In July, 1968, because of a possible UFO sighting made by myself and my sister (*International UFO Reporter* 7/8 1988 and 9/10 1990), I mentioned the subject to the people I worked with. To my surprise no one ridiculed me. This was because, sometime before I had entered this section (~1-7 1968), they had reported a UFO on the KEYHOLE photography. I was able to see these photographs. However they were classified, so I didn't write down identifying information.

The object on the photograph was shaped like a saucer with a raised dome in the center. It was over water. One could tell by the wave pattern of the water that the object was not in the water. This water was inland in or near the USSR,

and I think it was probably the Black Sea (it's hard to remember after that long a time). It was to the west of a mountain range having a secret Soviet military installation on the other side.

The object was photographed on at least two missions (photography from different passes around the earth). It was in a slightly different place during each of these passes, but was in the same general area. Because it was seen on more than one mission (a mission is 90 minutes), I made copies of it and photographically changed the object's size, until I had photographs of the object that were the same size, but from different viewpoints. I examined these in stereo, in order to more clearly view the shape of the object. It appeared to be saucer-shaped with a dome. This dome, however appeared to be quite tall in comparison to the brim--almost like a high top-hat (or like the Kecksburg, PA, object standing on end). I don't know whether this was actually the shape of the object, or whether the shape had been distorted by my method of photography.

The supervisors of this area told me that they had reported the object to the CIA as a UFO. (It was the normal protocol to make our reports to the CIA.) Although, the CIA almost always accepted their professional opinion about the identity of objects, the CIA did not accept this report. The CIA told them that what they saw was an imperfection on the film. The DIA argued that since it was photographed on two different missions (I recall at least 3 pictures--there may have been three missions or two pictures from one mission), it couldn't be a photographic imperfection. However this didn't change the CIA's reported opinion.

To further check, they sent the film to sensitometry and densitometry specialists. These people analyzed the film and reported that a real object had been photographed. The objects were not film flaws. My supervisors again reported this to the CIA and the CIA again told them that the photographs were not of objects, but were of flaws in the films. The specialists thought this was highly unusual behavior on the part of the CIA.

TUNNELS - Although I have not seen it, I have been told that the evacuation plan for Washington DC in an emergency involves the evacuation of a large number of people into tunnels and underground facilities. I assume there must be a very large tunnel system, or underground system under Washington DC, because of the large number of people and the amount of classified information and equipment that would need to be evacuated, if an emergency occurred. Emergency evacuation or relocation headquarters for Washington, DC civilian employees included: Camp Pickett, Blackstone VA. Other emergency stations included the Naval Academy, Anapolis, MD; Naval Air Station, Patuxent, MD; Naval Weapons Lab., Dahlgren, VA; Vint Hill Farms, VA; Marine School, Quantico, VA; Fort Detrick, Frederick, MD and other military installations. Such facilities might also contain tunnels, vaults, or other underground quarters.

Although underground tunnels are often mentioned as being in NM and places out West, there may be extensive facilities under Washington DC as well.

In April, 1993, my employer sent me to a conference which was being held at Wright Patterson AFB (WPAFB), Dayton, OH. Since WPAFB is probably one of the best known sites associated with the UFO phenomena (e.g., artifacts from Roswell and other sites have been reported to have been taken to this AFB and it was the home of Project Bluebook), I looked around and photographed the area in my spare time (see Fotos and Figures section).

The following information has been put together using this experience, information from several MORA "informants," the introduction to *Project Bluebook Special Report No. 14* (Dr. B. Maccabee), and *Far Out* magazine (Spring 1993 12-18). WPAFB is composed of Wright Field (named after the Wright brothers) south of Rt 444, and of Patterson Field, north of Rt. 444. It is divided into three areas, A, B, and C. It has extensive research facilities and was a Strategic Air Command (SAC) base from the 1950s to the 1970s.

Each of these areas is secured by tall chain-link fences with barb wire at the top and posted warnings such as, "It is unlawful to enter this area without permission of the Installation Commander...While on this installation all personnel and the property under their control are subject to search. This area is patrolled by military working dog teams and entered at guard posts."

AREA B contains the Air Force Museum, which is not fenced and is open to the public. It also has a secured building complex surrounded by fence, which can be entered only through various gates. Within

this secured area are the Avionics Laboratories, a number of Air Force buildings including materials and manufacturing technology buildings, and an old nuclear reactor. Some of these buildings can be seen by looking up the hill from the Air Force Museum. Among the buildings in this area is a nondescript brick building, Building 18, that could be the source of the famous hanger 18 disinformation stories. Building 18 on the Air Base map is shown as the Aero Propulsion Lab. It is centrally located in Area B, and is closely surrounded by other buildings.

Although the proverbial Hanger 18 does not necessarily exist, the hanger where the Roswell material was originally taken, may. A MORA informant reports that it is the second hanger from the left of a group of connecting hangers which are near the runway in area B. These hangers can be seen from the Air Force Museum area. They are located immediately downhill from the Avionics Laboratory and the nuclear reactor. Thirteenth St. runs from the hanger area to the Avionics building area. On current maps this group of hangers is simply identified as building 4 A-E. Thus, so called "Hanger 18" would be the B hanger. These hangers are large buildings that resemble drums cut in half and laid down in a series. He said that the airplane carrying the artifacts from Roswell landed on this runway and parked by the hanger which is located at the eastern end of this runway. The Roswell debris was then unloaded into the second hanger. This runway, for the most part, is now unused most of the time. However, some aircraft can be seen

parked in front of the hanger complex. There are bombing practice targets--photo targets, such as tanks and an unflyable F-4 located in the area.

Debris from Roswell was reportedly studied at WPAFB. Some is also rumored to have been taken to Battelle Memorial Institute and possibly to Ohio State University. (Dr. J. Allen Hynek worked for both places and, in addition, for the government.) Battelle Memorial Institute at that time had world class metallurgy capabilities and it would have been logical place for the material to have been studied. This reported study, so far as known, was probably a separate study from Projects Stork, White Stork, and Bear, which were the source of the so-called Pentacle letter. An examination of this letter is given in the *International UFO Reporter* (May/June, 1993 pgs 4-12).

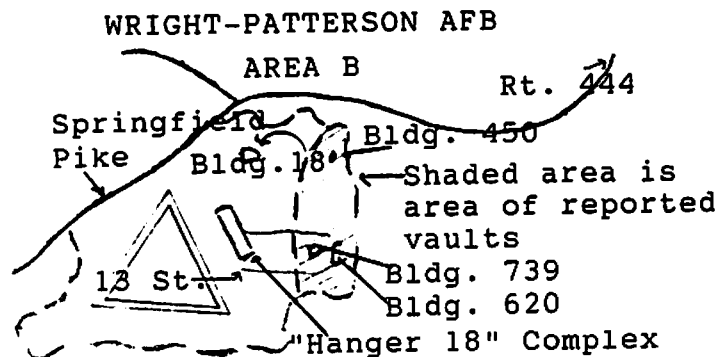
There are reports that large underground tunnels and cryogenic vaults exist in the Wright Field area. These were first constructed to preserve photographic material. They are reported to have later housed alien artifacts and bodies. The location of one such vault area is near to and connects with buildings 620, the Avionics Labs, and 739. Building 739, a small building, which reportedly contains a vaulted entrance to an underground complex, beneath the parking area for these buildings. Behind thick glass doors is a six-inch-thick bank vault door with a combination lock on the front of it. The power supply to this section is reported to be within the vault. Building 620 is the Avionics Lab and is distinctive because of its two large twin towers. (These twin towers are believed to be functional, rather than decorative. They were report-

edly used for dropping objects for materials testing purposes.)

There are also reportedly other large, hanger-sized underground areas in this same complex, built during WWII, where UFO wreckage could have been stored. According to some sources, these facilities are very large and deep. A source said that while working at WPAFB for a private contractor, he had seen workers open a large cement man-hole-like cover on the floor of one of the Wright Field buildings. He cannot now remember which one it was. The opening was the entrance to a huge vault or tunnel which was very deep. He noted that WPAFB had trouble with flooding in its tunnels. Several were reportedly full of water.

Another informant, who grew up in the Dayton, OH, area, says that it was common knowledge that Wright Patterson had alien artifacts. He recalls that people in his neighborhood (where many WPAFB personnel lived) openly talked about this. Another informant said that people, who work on the base still talk about this subject, but informally, because it is classified.

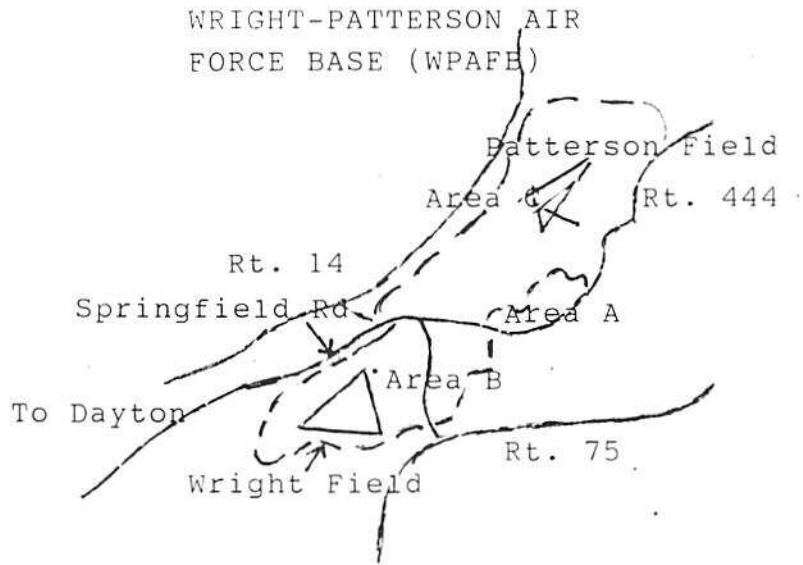
Map of WPAFB showing Area B in detail.



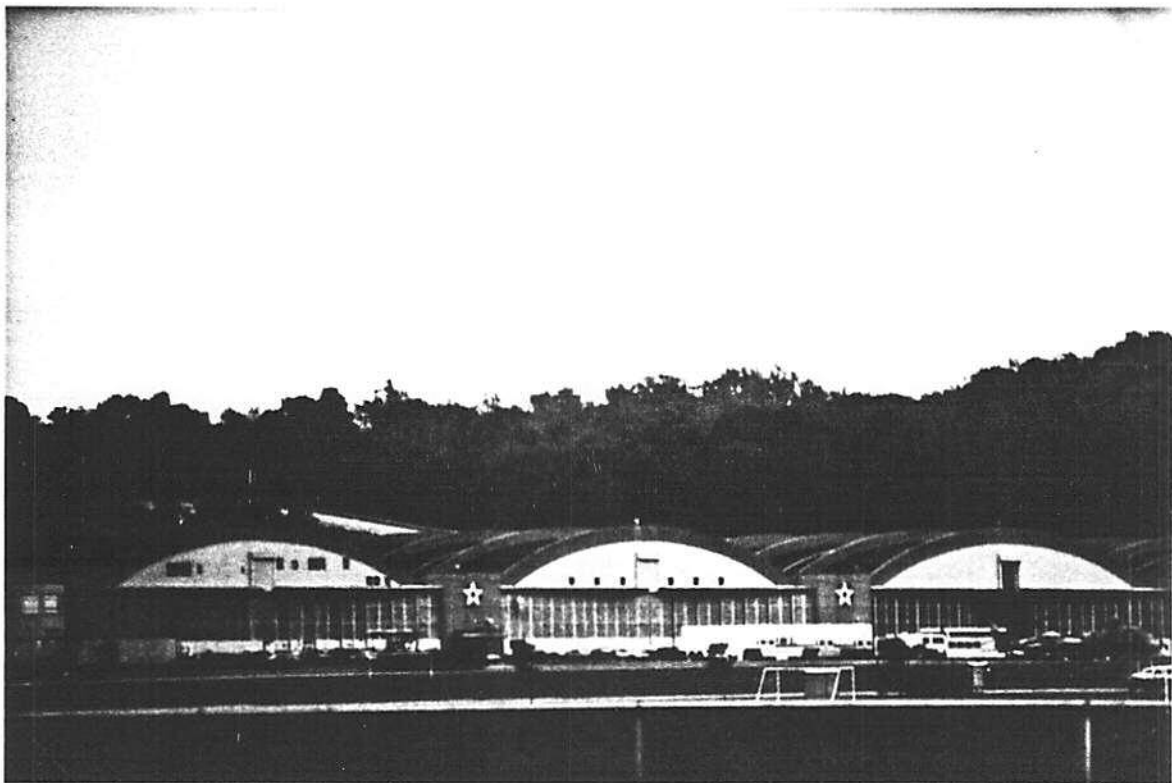
AREA A: An area of great interest is Area A, which is also surrounded by high chain-link and barbed wire. This area contains the old Air Technical Intelligence Center (ATIC), the home of various Air Force UFO projects, including Project Blue Book. The name ATIC was later changed to the Foreign Technology Division (FTD) and it is now known as the Foreign Aerospace Science and Technology Center (FASTC).

Another building of interest in the FASTC complex is building 856, now the FASTC headquarters complex. This building, unlike the other buildings on the base, is surrounded by its own high individual security zone. There are cameras located on the roof of the building pointing in all directions. A security system composed of machines that look like traffic lights surrounds the periphery of the building. This system extends out as far as approximately 100 feet from the building and into the parking lot. Warning signs state that the grass and private roads surrounding this building are a controlled area.

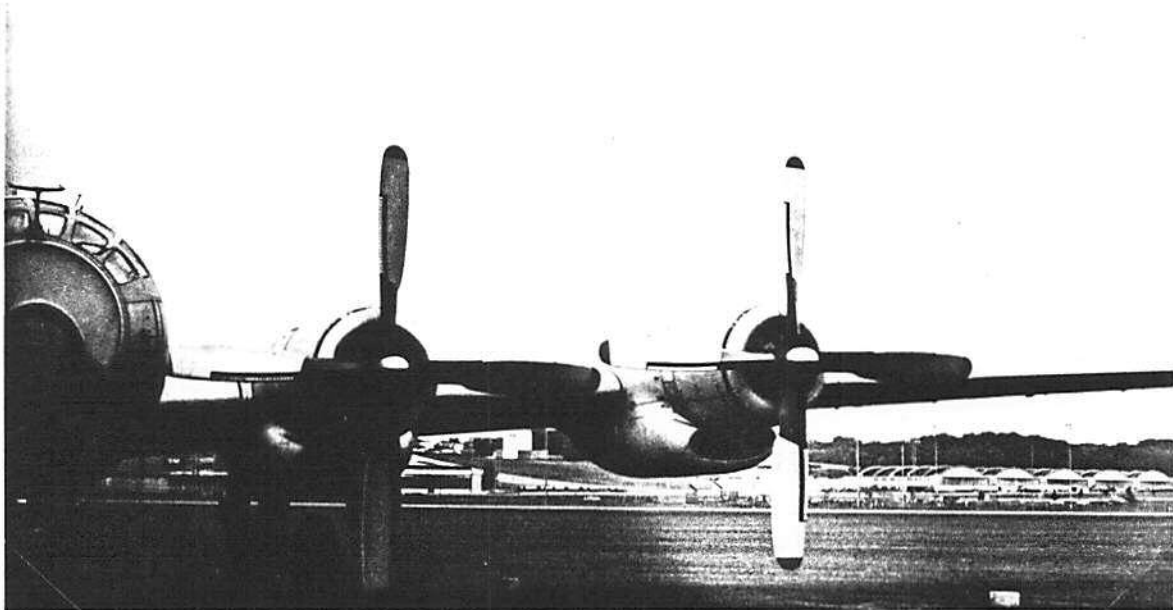
MAP OF WRIGHT-PATTERSON AFB (WPAFB) showing Areas A, B, and C.



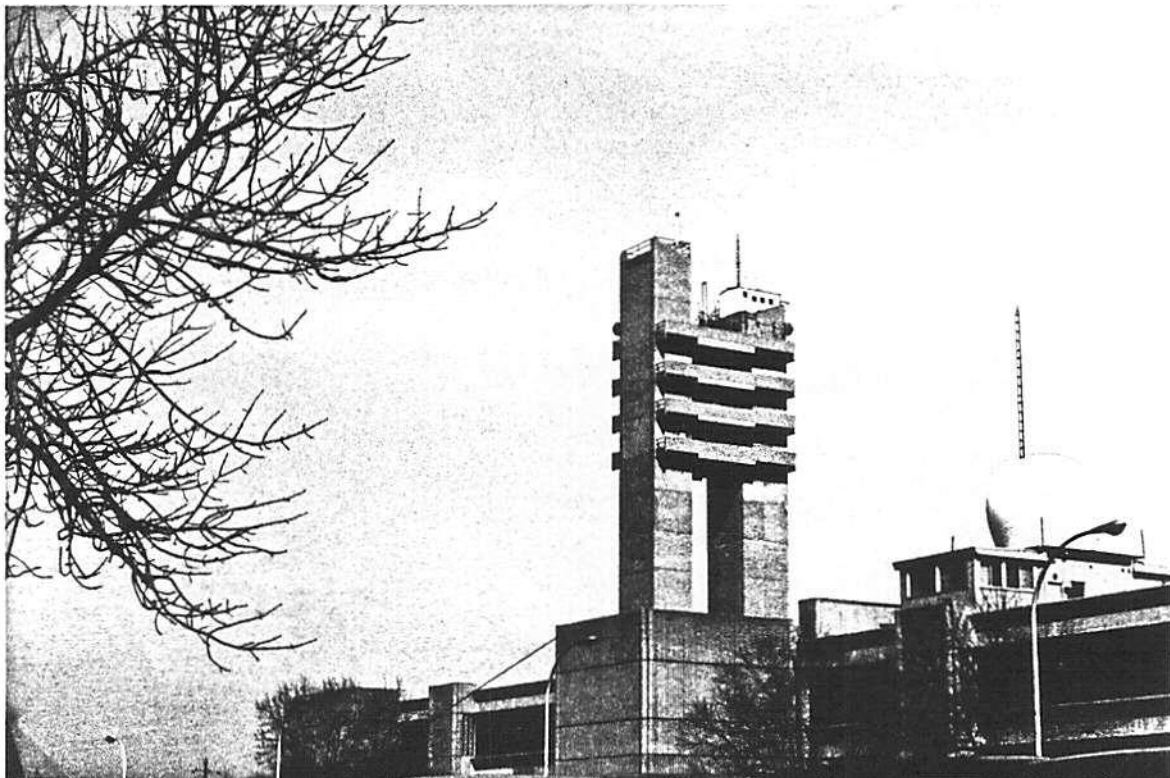

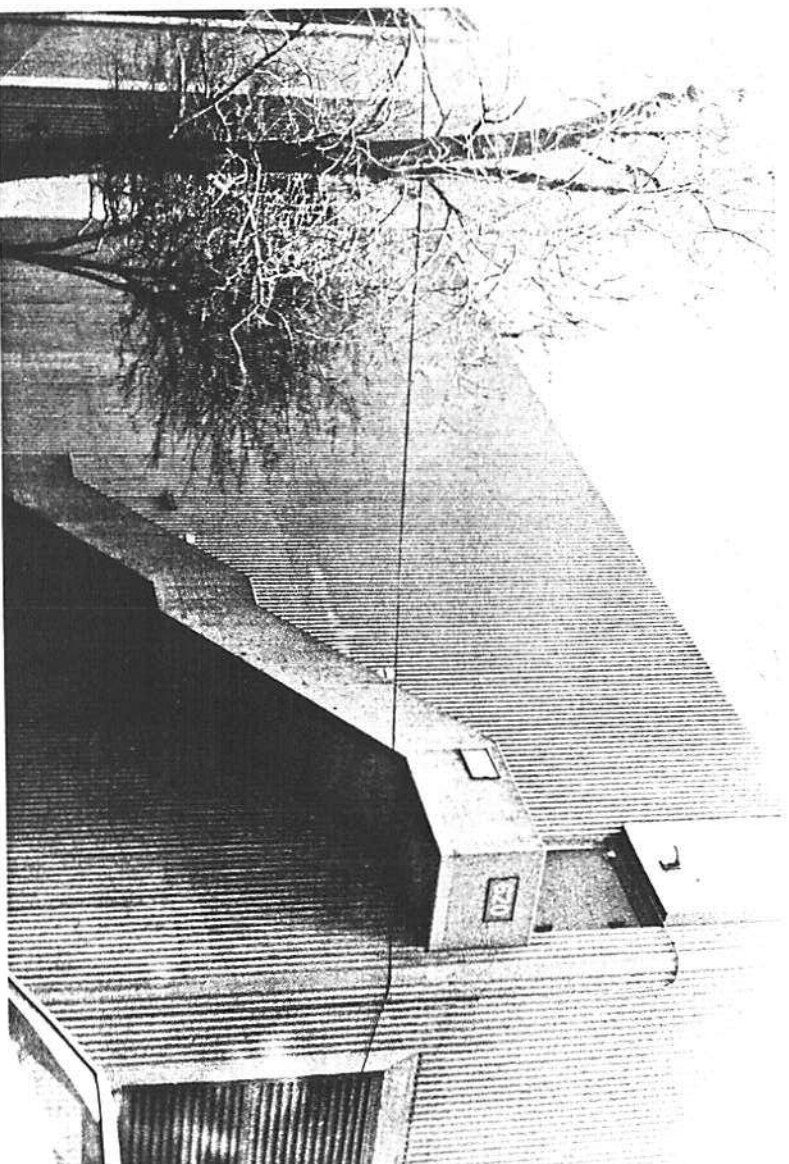
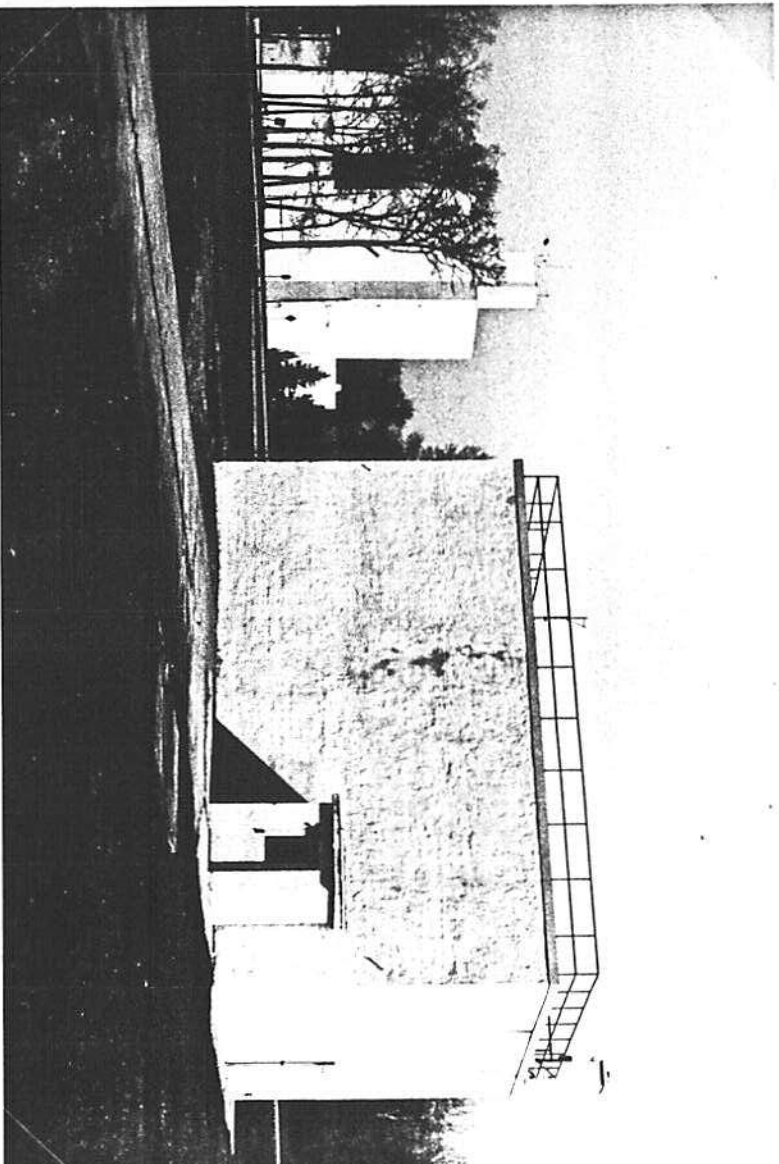

B-29 The bomb bay of a modified B-29 bomber.

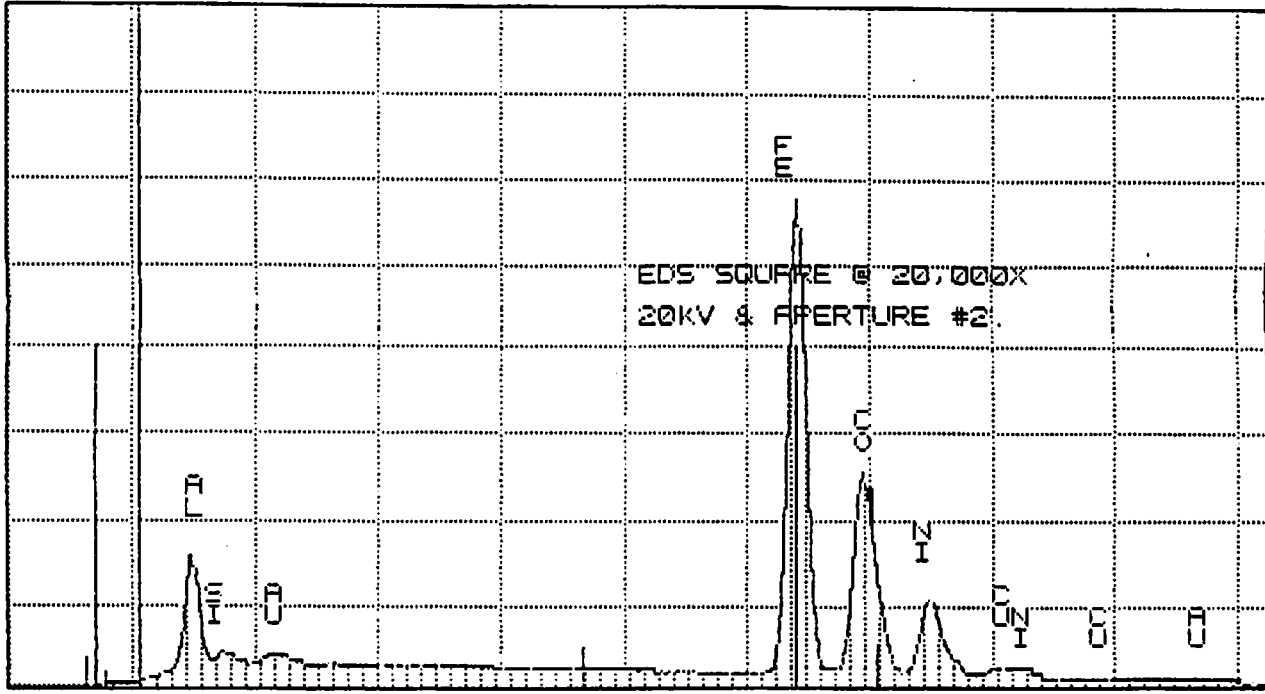


APPENDIX 1
